1. General comments

This mission report was prepared within the Twinning Project "Strengthening the capabilities of the Department of Statistics in Jordan". It was the fifth and sixth mission to be devoted to national accounts within Component 1 of the project.

The main purposes of the mission were:

- To continue the manual balancing process by balancing towards target totals
- To train the DoS staff so they during active balancing work become familiar with the balancing technique and with the common "Rules for balancing"
- To make plans for further work and agree upon work to be done before next mission scheduled January 2015.

The consultants would like to express their thanks to all DoS officials and individuals met for the kind support and valuable information which they received during their stay in Jordan and which highly facilitated their work.

The views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, DoS or Statistics Denmark.

2. Assessment and results

At the start of the November mission the Excel workbook containing the SUT-environment was fully populated with an initial version of the data. During that mission the product balances were looked through and differences between supply and use had been reduced to small acceptable values for most products. Before the start of this mission such remaining differences had been eliminated using the tools provided by the Excel-macro system for automatic balancing. However, for a number of products significant differences were still not explained, and had to be studied further before it would be possible to adjust input to the corresponding targets for total input in each industry.

At the beginning of this mission most of the remaining differences were removed. Balances for fertilizers (phosphate), maintenance, repair and installation (except construction) services and accommodation services still contained some unsolved problems and there still seem to be a need for some adjustments to balances for food products.

Some specific problems arose in connection with import and export of services according to the balance of payments. A double counting of transport included in the CIF value of imported goods had been removed from the import of services. According to the balance of payments figures there is a considerable net export of government services that does not seem to have a corresponding supply of sales revenue from general government. In principle this export cannot be export of health services, as services to foreign patients should, by SNA convention, be included in the travel expenses paid by non-residents. Furthermore it seems that the figures for supply of health services is too small to cover export in connection with "medical tourism" from which Jordan seems to have a considerable income according to several papers and home pages found in the internet. As temporary solutions the missing supply was added to output of general government and private health services, but a thorough investigation of the issue is recommendable as these export values have a size that significantly affect the general picture of the Jordanian economy.

It may be possible to throw some light on the calculations behind the balance of payment if a meeting can be arranged with relevant persons form the central bank. It may also be possible to get a better

understanding of the figures for output from public hospitals if a meeting can be arranged with relevant people from the Ministry of Finance.

The "Health complex" that includes output and use of pharmaceutical products, output and household consumption of health services as well as foreign trade in travel and treatment can to some extent be separated from other balancing problems. Hence, it does not necessarily delay the adjustment of input totals to targets for intermediate consumption for other industries.

Before adjustments of industry inputs to the targets for intermediate consumption by industry can take place it is necessary to ensure that these targets are as realistic as possible. At the start of the mission it was demonstrated how each target is composed of initial values and adjustments made necessary by the differences between the concepts from business accounting used in the SBS-data and the definitions used in national accounts. Well known examples are financial services (FISIM) and insurance services.

The initial targets for industry output and input were based on the survey data behind the SUT. A comparison between these values and the corresponding values from the current national accounts revealed a number of differences. During the mission explanations were found for some of the most significant discrepancies. It turned up that some "manufacturing" that takes place within units belonging to agriculture should be added to manufacturing of food products as it is not covered by agricultural production. A large production within manufacturing of machinery turned up to be missing from the survey data. The explanation was that a missing big enterprise had been added in the calculation of the current national accounts - as it definitely also ought to be in the SUT! It is necessary that distributions of output and inputs by products are determined for this enterprise before the next mission in December.

During the balancing of products supplements for informal activity have been added to output from specific industries where this seems to be the most credible explanation for missing supply. However, it is recommendable that a more systematic approach is used to determine the sizes of such supplements to targets for outputs and corresponding adjustments to the targets for intermediate consumption of the affected industries. If results from the ongoing project on non-observed economy (with participation from ISTAT) cannot be ready in time, we should at least look into whether such supplements are already included in the current national accounts figures.

Despite the fact that some adjustments to the target totals are still not sufficient, it was possible to perform some exercises in balancing industry inputs to input-target. Except for those industries that are seriously affected by the issues mentioned above, most industries now seem to have initial inputs that can rather easily be adjusted to the targets. If the outstanding questions can be solved early in the December mission, it still seems realistic that a version of the SUTs that has been through the "final" balancing to targets for trade- and transport margins, taxes and VAT can be produced at the end of the mission. It may still need some adjustments before it can be considered the definitive version of the SUTs.

3. Conclusions and recommendations

This mission concentrated on the second step in the manual balancing of the SUT: The balancing towards target totals. The goal was to complete this part of the balancing process during the mission and leave the final (more automatically) balancing procedure to a final mission in mid-January.

Of cause, the balancing towards target totals must begin by a confirmation the very same target totals.

Before the mission, we had been working on the balancing of the products. During that process it turned out that some targets were changed and some questions arose. Especially balancing of the values for health services raised a number of questions addressed in a "Note on supply and use of health services", see Annex 5.

A comparison of the SUT-targets with the current National Account figures for Jordan also revealed differences that had to be explained or lead to further changes in the targets.

During the mission we were able to solve some of the outstanding issues concerning the target totals. But this part of the work turned out to be more troublesome than foreseen. As a consequence there was not enough time for the actual balancing work and some manual balancing toward targets still has to be done.

And even some target totals still has to be decided upon.

In addition to this, the independent calculations of the Informal economy, that is part of this component of the twinning project, should also be taken into account.

To be sure that we will be able to final balance the SUT during the next mission in January 10-15, we will therefore recommend:

- In accordance with the Italian recommendations the remaining calculations for the informal economy should be finalized and send to the Danish experts by the end of this year.
- Pre arrange a meeting with relevant persons in the Central Bank of Jordan. The meeting should be held Sunday 11/1 2015 or Monday 12/1 2015. Prepare an agenda.
- Pre arrange a meeting with relevant persons in the Ministry of Finance. The meeting should be held Sunday 11/1 2015 or Monday 12/1 2015. Prepare an agenda.
