## Analysis of the pilot survey

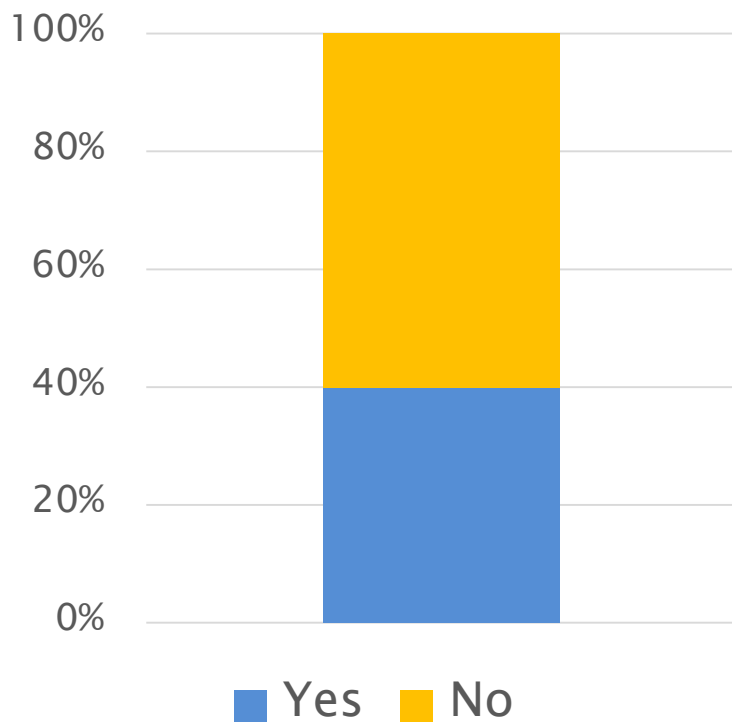
- Pilot survey on social exclusion conducted after the 1st mission, results were available before the 2nd mission
- Data quality very good:
- **Coherence** with similar questions from the Armenian main ILC-survey excellent
- Comparison with EU-SILC low-income countries: results of the pilot **plausible**



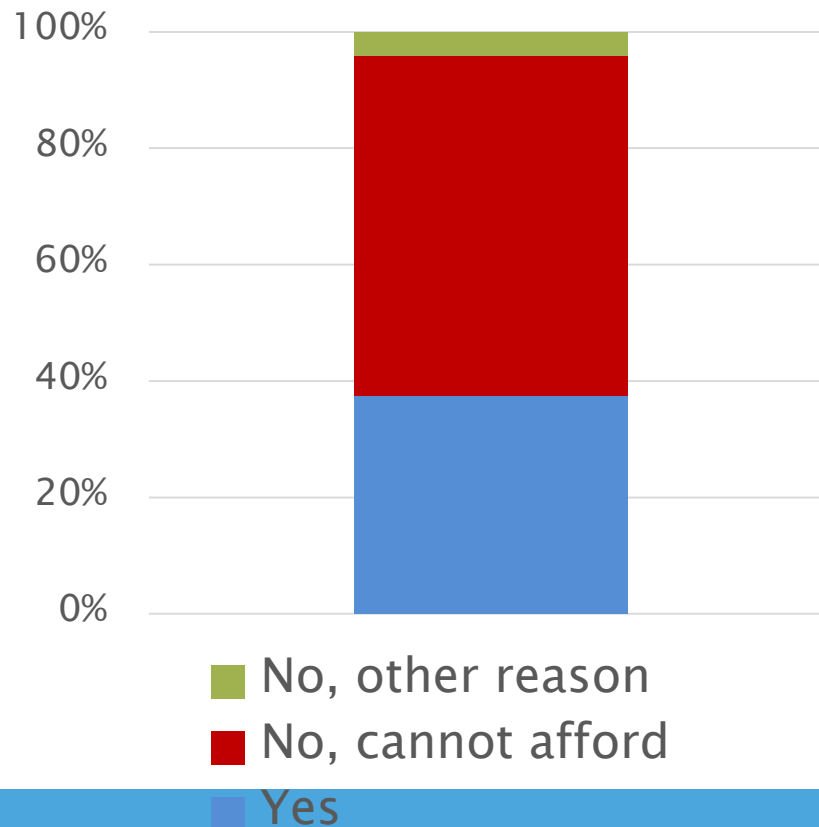
## Coherence: ILC survey vs. pilot

ILC survey



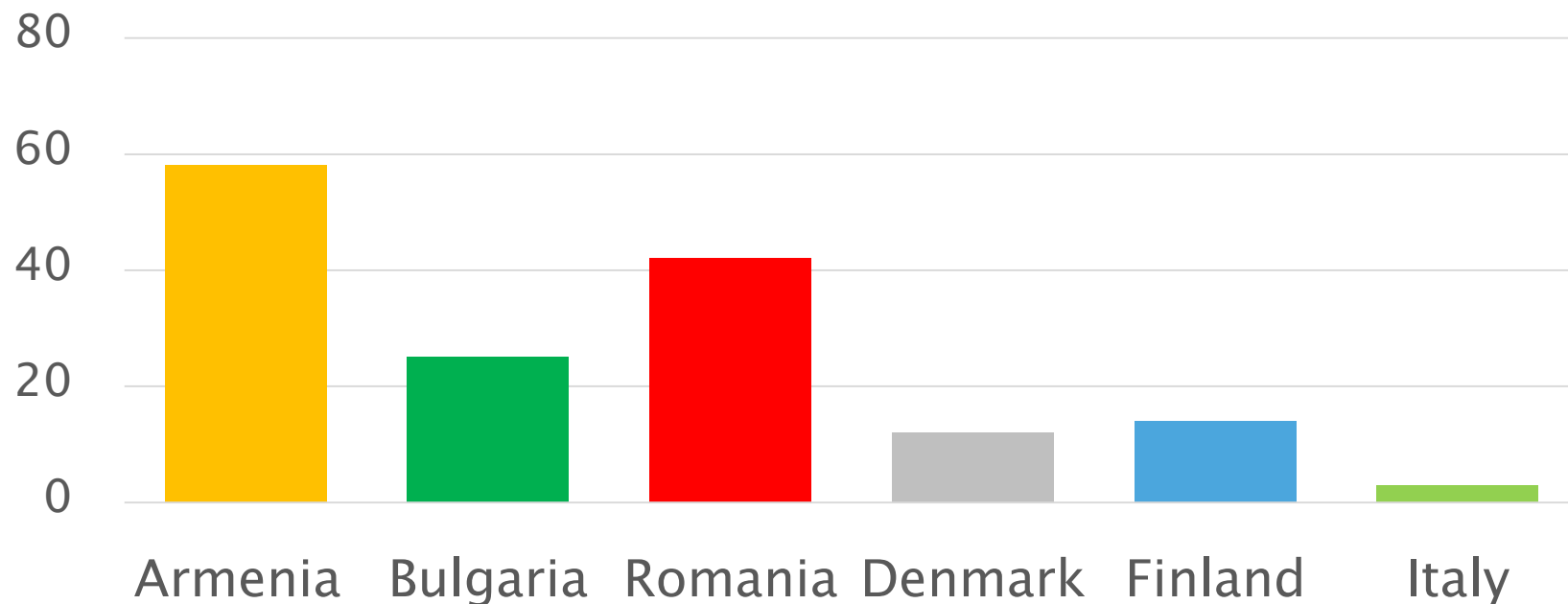

Share of households who cannot afford to buy a car

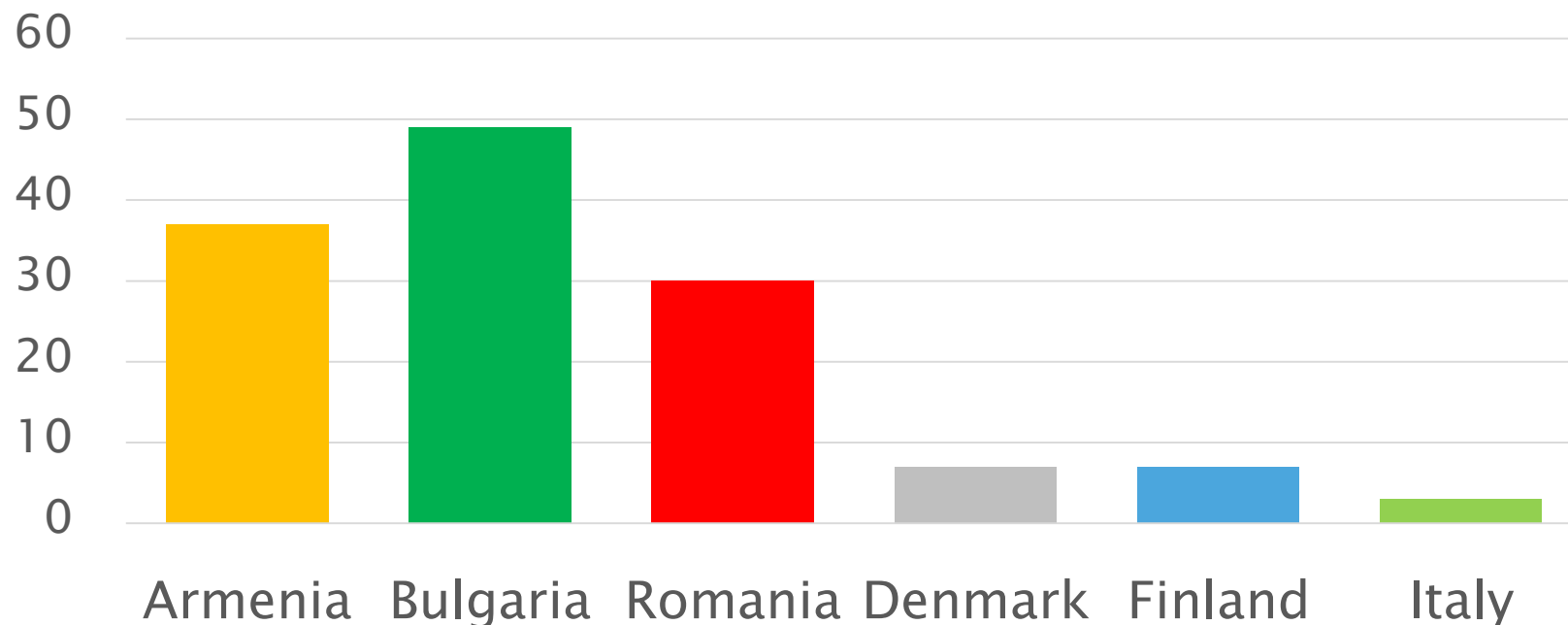

# Recommendations

From pilot to ILCS & Child Needs Questionnaire: finalization of questionnaires

Input	Output	# Questions
SE Pilot 10/2015	ILCS new questionnaire for 2016	6
	Separate module for 2016	14
	CNQ for 2016 or 2017 (according to NSSRA/Unicef's choice)	6
	ILCS new questionnaire for 2017	20

Proposal for full integration, in two annual steps, is comprehensive:

- wording for new questions
- positioning with respect to ILCS current version
- technical notes on new informational contents





## Further steps

### Main statistical output from 2016

- to estimate the indicators for Material Deprivation for the entire HH population (according to EU regulation)
  - old version: list of 9 items, valid till 2015
  - new version: list of 13 items (6 in the previous one), from 2016
  - EU and Armenia will start in parallel with the new indicator
- to enrich child-specific contents for HH with children aged 1-17
  - comparable with Eurostat standards (not under EU regulation)
  - satisfying Unicef's informational demand
