1. General comments

This was the fourth activity in component 3 and the actions planned for this activity were carried out as scheduled in the ToR, cf. annex 1 and the programme, cf. annex 2. The purposes of the mission were:

- Discuss the draft templates for a standard DoS quality declaration based on EU standards
- Discuss how the quality declaration can be published and how they can be linked to the statistical outputs
- Discuss the level of granularity, i.e the level at which, the quality declaration should be established. E.g. one for the whole national accounts or one for the annual national accounts and one for the quarterly national accounts

Thursday morning the consultants had the opportunity to meet the recently appointed Director General for DoS, his Excellency Dr. Qasem Al-Zubi, also Mr Abed Wadood Matouk and the RTA participated in the meeting. The meeting was highly positive, and his Excellency Dr. Qasem Al-Zubi supported the consultants' work and also stressed the importance that this was an good opportunity for DoS to reduce the gap to international standards.

The consultants would like to express their sincere thanks to all officials and individuals met for the kind support and valuable information which we received during the stay in Jordan and which highly facilitated our work. The views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, DoS or SD.

2. Conclusions and recommendations

2.1 Checklist for Data Quality Assurance

The checklist developed during activity 3.3 had been tested successfully by DoS, who used it for the Agricultural Employment Survey. The checklist proved to be useful for statistics in general.

Recommendation: Use the checklist for all new statistics and for new waves of existing surveys.

2.2 Quality Declarations (QD)

A draft template for QD was agreed during activity 3.3. The template had been successfully tested for Economic Surveys, and the resulting draft was presented to the experts. The draft QD was discussed and compared with content of Danish QD. A number of amendments were proposed and discussed during the mission.

The conclusion is that the template is ready to use in all existing and upcoming statistics. Therefore, the recommendation is to go ahead and implement the template. In order to do this, DoS should start to develop comprehensive guidelines for content of each item, so that statisticians responsible for the statistical products can fully understand the task.

2.3 Producing Quality Declarations

DoS should now start implementing the QDs in order to eventually having QDs for all products, which will greatly benefit users. First, DoS should complete the QD for Economic Surveys, based on the inputs and discussions during the mission. As was proposed by DoS, the QD should be split in 5 QDs, one for each survey. DoS was invited to send the result to SD, who promised to review them shortly and send back further comments and proposals.

In the domain of national accounts, DoS should draft QDs for:

- Quarterly National Accounts
- Annual National Accounts
- Input-Output Tables (when these are produced, maybe in 2 years?)

The issue of granularity of QDs was discussed, i.e. what should be the "unit" to be described in a QD. It is recommended that one QD is made for each statistical product. The statistical product is defined as:

- Similar subject and/or common source used
- Published as one product

In DoS, this would probably lead to around 100 QDs

2.4 Training course in Quality Declarations

DoS has decided to have a training course in QD, easing the production of high quality and homogeneous QDs. The experts proposed the following elements in a one-day course with max. 20 participants (heads of divisions, who will then train their staff):

- 1. What is quality? Quality dimensions (short introduction)
- 2. The quality checklist and its application (short introduction)
- 3. What is important for users to know about your products?
- 4. The quality declaration template (short introduction)
- 5. Thorough explanation of each of the items with examples, based on written guidelines (3 hours?)
- 6. Practical exercise: try to fill in selected items

After the course participants should be given the following home work: submit a draft QD for each product.

These drafts should be reviewed by the Quality Division

2.5 Publishing the Quality Declarations

Following a discussion with the head of Electronic Dissemination, the experts recommend:

- Establish a dedicated area for QD on the DoS web site
- Store all QD in this area in a simple format like PDF
- Link to relevant QD in Press releases
- Link to relevant QD from tables and databases

A long term objective for DoS should be to include the QDs which will be created during the Twinning Project in an integrated, comprehensive metadata system, also comprising detailed variable descriptions, concepts database, and classifications database. The contents of the QDs should be inherited by such a future system.

2.6 Updating

Each QD must be updated by the responsible statistician before publishing each new wave of the statistical product (e.g. Economic Surveys, Quarterly National Accounts...)

3. Program for next mission (August)

Thursday morning a draft lineup of a program for the next mission in august was presented for the quality team. The quality team were very positive to the lineup and supported the content. It was also decided to add, that a draft version of a quality declaration of the Population Census will be presented by DoS. The consultants will then present an example of a QD for a Population Census for a European country. On the basis of this information it would be possible to carry out elements of the DoS quality declaration for Population Census.

The lineup for the next mission is as follows:

Review final drafts of QD for:

- 5 economic surveys
- Quarterly National Accounts
- Annual National Accounts
- A few other statistics

Population Census:

- SD to present a QD from an EU country
- DoS to present elements of QD for the Jordan Census

Review experience from training course

- Report from quality team
- Interview with participants (consultants)

Publishing quality declarations

- Test version of web site with QDs presented by Electronic Dissemination Division, incl. at least two real QDs
- Review of presentation of QD on DoS web site

Seminar with key users where QD is presented

• Held by the consultants
