Executive Summary

The main aim of the mission was to assess the current situation on ESSPROS and to discuss how to improve the data collection.

During the first ESSPROS pilot project, the ESSPROS framework was applied to Bosnia and Herzegovina resulting in the development of questionnaires and a first data collection. According to the results of this first pilot project the data collection and implementation of the ESSPROS methodology will have to be improved in order to meet the requirements of Eurostat. This is the reason for starting this second project. The main objectives of this second project are to encourage a close cooperation with all relevant data providers, improve the accessibility of qualitative and quantitative data and to develop a regular survey.

The social protection structure in Bosnia and Herzegovina is similar to the administrative structure. The 3 main entities in Bosnia and Herzegovina are: Federation of BiH (FBiH), Republic of Srpska (RS) and Brcko District (BD), This administrative structure is complex, because of its decentralized structure consisting of a state-, entity-, canton and municipality level and the number of institutions. An example of this are the fourteen Ministries of Finance (1 at state-level, 3 at entity-leveland 10 at canton level).

The statistical office of FBiH has more problems of collecting data on social protection than the statistical office of RS, because of its decentralized structure. Therefore during the first mission of the second pilot project the main focus was on the situation in FBiH. However, the discussions are helpful to RS and BD as well, since they face similar situations such as the problems regarding the quantitative and qualitative information. The statistical offices of FBiH and RS did not receive any data related to social assistance, respectively from the Ministry of Labour and Social Affairs (FBiH) and the Ministry of Health and Social Welfare (RS).

1. General comments

This mission report was prepared within the Twinning Project "Support to the State and Entity Statistical Institutions, phase VI". It was the first mission to be devoted to ESSPROS within Component 4.1 of the project.

The purposes of the mission were:

- - Assess the current situation on ESSPROS
- Discuss how to improve the data collection

The expected activities were:

 Assessment on the current situation, including presentation of the developing ESSPROS so far during the UNICEF project

- Overview over EU regulations and requirements in this area
- Presentation of the Denmark, Latvia and Netherland experts for ESSPROS
- Analysis of different possible sources for data collection
- Identification and classification of social protection schemes
- Discussion on how to improve data collection and prepare for the pilot survey
- Review of questionnaire and instruction for filling the questionnaire
- Draft Activity plan for the pilot data collection
- Link with National Accounts

Assessment of the current situation, including presentation of the development of ESSPROS so far during the UNICEF project

There are four statistical offices in Bosnia and Herzegovina: Agency for Statistics of BiH at state-level, Institute for Statistics of Federation of BiH and Institute for Statistics of Republika Srpska and Agency for Statistics of BiH- branch District Brcko at entity-level.

The national experts were informed on the complex situation in BiH with different degrees of decentralisation in the different entities. As the highest degree of decentralisation exists in FBiH and the difficulties in collecting data are considered most problematic here, it was decided to focus on the data collection in this entity.

The statistical offices in BiH and the national experts find the work developed so far on ESSPROS during the first pilot project useful as a starting point for the next pilot data collection and for the further development of the work with ESSPROS in BiH. The staff responsible for ESSPROS seems to be quite aware of what still needs to be done in order to collect data for ESSPROS and this project will assist them through giving an opportunity to discuss methodological questions and to learn from the experience in other countries, and also

through assisting them in the data collection by making the data providers give a higher priority to this data collection due to the international presence.

Already available for ESSPROS:

- Charts showing the political and administrative organisation important for social protection in BiH (state level), FBiH, RS and BD
- Report from the pilot survey
- Questionnaire and schemes from pilot survey
- Contacts in several relevant institutions
- Data from pilot survey
- Questions to institutions as a result of the pilot survey (validation report)
- Experience gained in the statistical offices
- Knowledge of the existence of several relevant laws on social protection

Main reporting units in FBiH (Sarajevo):

- Institute for Employment (Employment Fund)
- Federal Pension and Disability Insurance Institute (Pension Fund). 60 per cent of social protection expenditure for ESSPROS is gained from the Pension and Disability fund.
- Health Insurance Fund = Institution for Insurance and re-insurance
 - 10 cantons (own social protection laws and are not obliged to share data)
 - 79 municipalities
- o Ministry of Labour and Social Affairs (federal level) is responsible for social benefits distributed through the Centers for Social Work. FBiH has most problems with the social assistance on canton level and here it was most difficult to do the pilot survey. They did not fill in the survey for social assistance.

RS (Banjaluka)

During the meeting the colleague from RS mentioned that due the centralized social protection system it is easier to collect the data on ESSPROS than FbiH, but they still need to improve the quality. Staff in reporting units in RS has been trained in ESSPROS.

- o 62 municipalities;
- o From the 1st pilot survey RSIS did not receive any data on social assistance.

BD

Brcko district can choose from which entity it can receive the pension benefit either from FBiH or RS.

Overview over EU regulations and requirements in this area

This has been highlighted during the presentation of Latvia about their experience with ESSPROS

In 2007 and 2008, three new pieces of legislation were introduced in the field of social protection statistics:

- European Parliament and Council Regulation No 458/2007;
- Commission Regulation No 1322/2007;
- Commission Regulation No 10/2008.

In 2011 two further pieces of legislation were introduced in the field of social protection statistics which focuses on the net social protection benefits:

Commission Regulation (EU) No 110/2011;

Commission Regulation (EU) No 263/2011.

Presentation of the Danish, Latvian and Dutch experts for ESSPROS

Presentations were provided by Latvia and The Netherlands. Denmark did not present because its cases are similar to the Netherlands.

Analysis of different possible sources for data collection

The problems concerning the collection of data (quantitative and qualitative) from the different institutions were considered. The possibilities of getting data from other institutions were considered (see below) and will be further explored in the future, but the coming pilot data collection will rely on the former reporting units.

The risk of double counting was explained and for illustration of this problem, as well as for presenting a way of analysing the flows of expenditures and receipts, a chart over the financing flows of one of the reporting institutions was elaborated.

One of the challenges is to encourage the different institutions to share data. The statistical offices mentioned two reasons for this: The sharing of data results in additional work for the offices which is a problem due to the limited capacity in terms of employees and financial resources. Another reason is data confidentiality. Based on this The Netherlands gave some examples on how this is organized in the Netherlands. When having meetings with reporting institutions it is important to have an intermediate person from the EU twinning project involved in those meetings. Another thing is that it involves top management cooperation of institutions of Bosnia and Herzegovina in order to establish collaboration between the different parties and it will probably require the signing of cooperation agreements between the different institutions.

Suggestions for other institutions to receive data from:

- Tax Authority
- Central Bank
- Ministry of Finance

- Research and agency of economic planning
- National Accounts
- Yearly reports from relevant institutions

Identification and classification of social protection schemes

BiH has the schemes on an aggregated level and not further specified to type of benefit, i.e. according to the characteristics of the beneficiaries.

BiH has made a subdivision of the schemes per entity and district. In one case, for the Health fund, they have made divisions for the FBiH at canton level. In the future this might be on entity level of the FBiH. After the pilot survey they have identified two new schemes: Municipality (3 schemes) and NGO (independent social assistance from non-government organizations), which incorporates mostly social exclusion functions. The statistical institutions prefer to keep the schemes as they are and quality information is needed to support the data they have received so far from the first pilot data collection.

Discussion on how to improve data collection and prepare for the pilot survey

The two major challenges for this second pilot project are data collection and understanding ESSPROS methodology. Some of the specific problems mentioned are listed below:

- Municipalities are supposed to pay out the benefit but they do not. An example of this is the child support benefit. This will become a problem if estimations of these data are necessary, and when comparing with real data. The resources are not available to pay out the required child support benefits which should be paid out according to the law.
- Data providers do not have the same definitions as ESSPROS. Translation of definitions from data provider to ESSPROS is a problem.
- Lack of training and computers due financial resources.
- Reporting units do not know what to do how to fill in the questionnaires.

Suggestions to improve quality information (see also action points)

- Complete financial reports from the data providers
- Use of legislation of the social protection system in Bosnia to identify the type of benefits and extend the quality information of the schemes. These laws and administrative orders are publicly available on the internet, but it requires time to study in order to understand and interpret them. Both statistical offices are afraid that once they provide this kind of description to the data providers they will realize that they did not comply with the rules, such as not being able to pay all the benefits that are required, because the budget it is too small. -However, it could be stated that the listing of benefits according to the legislation is included as a help for completing the questionnaire.

Draft Activity plan for the pilot data collection (see action points)

Draft questionnaires for pilot surveys adopted

The questionnaires used for the first pilot survey are very similar to the ones from Eurostat. There were suggestions on how to improve the questionnaires in order to make it easier for data providers to provide the correct data. The improved questionnaires will probably be used in the next pilot survey.

Links with National Accounts

It was suggested by the experts to use National Accounts data as a possible source for ESSPROS. Based on this suggestion experts had a meeting with the deputy director of BHAS Ms. Slavka Popovic and assistant director of National Accounts of BHAS Ms. Dijana Mlikota.

The Assistant director of National Accounts advised to use the bottom-up approach. She mentioned that there are 14 Ministries of Finance and mentioned that the system is very complex and decentralized. At this moment it is not possible for the coming years to use the National Accounts data for ESSPROS because it is too premature. At the moment only the production accounts are developed. She advised to continue to work with the recommendations of previous expert Mr. Flavio Bianconi, because she thought them to be of high quality. The changing country structure after the war is probably the reason why the National Accounts have to be compiled from scratch according to the definitions of ESA 2010. Originally compilation of the National Accounts started in 1993. According to the NACE entity, National Accounts will be classified according to the regions. The problem of National Accounts is that they do not have access to the data sources, because the institutions are situated on canton level and decentralized to the four Ministries of Finance. Each Ministry of Finance is independent at canton level and does not want to share the data.

However, the Assistant director of National Accounts is interested with a cooperation regarding ESSPROS and does acknowledge the benefits of it. A recommendation would be to involve NA again once the results from the pilot survey are obtained and the results are positive. Then it can be examined whether it is possible to use data from NA or provide ESSPROS data to NA to improve the quality of the survey and the data of NA.

The deputy director of BHAS believes that a solid approach has been established by Mr. Flavio Bianconi and this approach should be elaborated. The focus should stay on the questionnaire or pilot study instead of exploring the possibilities of other sources of administrative data. The motivation for this is that the situation of Croatia is similar to that of Bosnia. Croatia has successfully complied the data with the requirements from Eurostat and therefore recommends the same approach for data collection as Bosnia and Herzegovina. On the one hand, it would be advisable to keep other options open as well in order to be able to adjust the strategy when needed. For example sharing the same data and knowledge will

increase efficiency, quality, cooperation, same definitions, less questions from other institutions and will prevent that the same data is asked twice from the same data provider. Eurostat encourages to produce consistent accounts for which the link between National Accounts and ESSPROS is an example, which is performed already by several EU-countries. On the other hand, the experts agree to keep the main focus on the questionnaire and will build further on the work that has already been done.

3. Conclusions and recommendations

During the mission it was agreed:

- To continue the work done in the first pilot study
- To keep exploring the opportunities for cooperation with NA when possible
- To concentrate on the reporting units in FBiH
- That a letter signed by the project management has to be sent to the reporting units in FBiH, RS and BD in order to further their appreciation of the importance of the questionnaire and increase the response rate as well as the reception of qualitative data
- To improve the questionnaire (see action points).
