Executive Summary

The present mission carried out under component 2 - National accounts of the twinning project had as main objective to support KAS for the estimation of annual GDP by production and expenditure approaches, at current and constant prices, for the year 2014 and revision of quarterly data.

The estimates of GDP 2014 were finalised during the mission and KAS will publish them on 10 November 2015. The calculations were based on available data sources, means turnover of enterprises provided by Tax Authority, financial statements of financial units (Central Bank, other commercial banks, and insurance companies), Balance of Payments(BOP) provided by Central Bank, expenditures and revenues of general government provided by Ministry of Finance and statistical data (Structural Business Statistics(SBS) prices as PPI, CPI, Construction Cost Index (CCI) and agriculture prices).

Following the plan established last year, KAS improved the dissemination of GDP and will publish for the first time the estimates by production and expenditure approaches, at current and constant prices, at the same time. The first estimates for 2014 were available in June 2015 (as sum of quarterly GDP). The quarterly data will be revised based on the final estimates for 2014.

1. General comments

This mission report was prepared within the Twinning Project "Support to Statistics".

The concrete objective of the mission was to support KAS for the estimation of GDP 2014 by production and expenditure approaches, at current and constant prices.

This views and observations stated in this report are those of the consultant and do not necessarily correspond to the views of EU, KAS or Statistics Denmark and our implementation partners(NI-CO/Statistics Finland/Istat/Statistics Lithuania).

2. Assessment and results

The present mission was focussed on GDP estimation at current and constant prices for 2014 The estimates were based on available data sources. The main sources used for the estimates were:

- Turnover of non-financial units provided by Tax Authority;

- Financial statements of financial units (Central Bank of Kosovo, other commercial banks, insurance companies);
- Financial statements of government concerning the expenditures and revenues, provided by Ministry of Finance;
- Balance of Payments (BoPs) provided by Central Bank of Kosovo
- Structural Business Survey (SBS) for 2014
- Statistical data concerning the prices (Producer Price Index (PPI), Consumer Price Index (CPI), Construction Cost Index (CCI) Import Price Index (IMPI) and agriculture output and input prices.

The provisional results of SBS were available at the beginning of the mission. Data were analysed, but several inconsistencies were found as: (i) value of the turnover was different from data provided by Tax Authority; (ii) share of intermediate consumption in the output presented unrealistic results. In this condition, for the estimation of national accounts indicators of non-financial units it was decided to use data from Tax Authority concerning the turnover and changes in inventories. The estimates were based on these data and the structure of the economy from the previous year

The output of government was estimated based on cost approach, using the detail information from Ministry of Finance. A new classification of transactions was used, based on the GFS codes established together with Ministry of Finance during the mission carried out in September 2015. The estimation of consumption of fixed capital (CFC) followed the PIM method established one year ago with IMF support.

The output of financial sector was estimated based on data provided by Central Bank of Kosovo; FISIM was calculated based on the ESA 2010. It was calculated as sum of the bank interest on loans less the SNA interest on the same loans plus the SNA interest on deposits less the bank interest on the same deposits. Export of FISIM was estimated using the external interbank reference rate, for loans granted to non-residents (excluding Financial Intermediaries) and for deposits of non-residents (excluding Financial Intermediaries). Based on the available data on stocks of loans by activity and by type, the FISIM was allocated to various users. FISIM was allocated to industry, and to the users (household final consumption, government final consumption and export). Estimation in constant prices was made using the general CPI.

The national accounts indicators of NPISHs were estimated based on the financial statements of these units provided by Ministry of Public Service.

As it was not possible to use the SBS results, the intermediate consumption of non-financial activities was estimated based on data provided by Tax Authority and its share in output from the previous year.

The estimates of output 2014 in the prices of the previous year were made using the corresponding PPI and CPI; for the intermediate consumption, the share of intermediate consumption in output from the previous year was used.

Households Final Consumption (HFC) was estimated based on the commodity flow approach using the template of calculations established one year ago. Some adjustments were realised, in order to follow the ESA 2010 methodological requirements.

The GFCF included the investment in machinery and equipment, construction, and agriculture, and the capitalization of expenditures on R&D and weapon systems. The estimation of construction is based on the input method. The value of raw materials obtained from imports and domestic production (minus export) represents the IC; this is adjusted with import taxes, VAT, and trade margins. The output is estimated based on a ratio of IC in output, which was considered to be 70 percent.

Investment in machinery and equipment is calculated based on custom data (assuming that the domestic production doesn't provide that type of products). The data are grouped by BEC and the codes 41, 42, 52 and 53 are used for the estimation of GFCF. The final data includes the custom duties and taxes paid for machinery and equipment.

The constant prices estimates for construction and investments in machinery and equipment was realized using IMPI.

Data on import and export of goods are provided by Custom Authority; for services, data from the Balance of Payments (BoP) are used. The estimation of import of good in the prices of the previous year was based on IMPI; for the export of goods, the corresponding PPI were used. The import of services in constant prices was estimated based on the average CPI of Germany, Albania and Macedonia, which are the main commercial partners of Kosovo; export of services was estimated using the corresponding domestic CPI.

3. Conclusions and recommendations

During the mission, detailed recommendations concerning the estimation of annual GDP by production and expenditure approaches were provided.

It was recommended to improve the organisation of work in annual economic statistics. The results of SBS, which is the main data source for annual estimates of GDP, were not used due to the poor quality of data. It is necessary to develop a detail work plan for SBS with deadline and responsibilities, starting with the design of the questionnaire until the publication of the results, including the estimation of the sample, the organisation of data collection, the data entry and validation process, the growthing-up methods and dissemination of data. It was recommended to improve the questionnaire, and to link the requested data with accounting forms provided by units to Tax Authority.

Further support to KAS including consultations and discussion with National Accounts Department concerning annual and quarterly national accounts compilation.

This mission is a continuation of previous mission on NA improving quality of National Accounts in Kosovo.

For the first time, KAS will publish annual GDP estimated by production and by expenditure approaches in the same time, means at the begining of November 2015. A dedicated publication will be designed in order to present to the users the annual GDP estimates.

KAS implemented quarterly GDP (QGDP) during the period 2014-2015 and a time series 2010- I quarter 2014 was published in December 2014; the other quarters of 2014 were published during the first semester of 2015. In this way, for the first time, quarterly data for the year 2014 were published before the annual estimates. The quarterly data will be analysed and revised in line with annual estimates of GDP 2014.
