Conclusions - Vital statistics

Undercoverage estimates based on the 2011 Census results:

- For births: 1.21%
 - max in Gegharkunik: 2.27%
- For deaths: 2.88%
 - max in Armavir an Gegharkunik: 4.17 and 4.11%

Input to the Interagency Working Group on Civil registration and Vital Statistics



Progress in documenting data processing

Changes to the electronic data collection request further analysis and testing:

 specifics of the data acquisition software (some controls are built in, others have to been developed at NSS in order to ensure accuracy of information)

Possible issues about the coding of causes of death



Recommendations – Vital statistics

To improve analysis of data available on undercoverage

- more elaboration on census data (time, territorial and hh profile disaggregation)
- comparison between population estimates and census results for chosen cohorts

To complete documentation about data processing (checking and editing procedures) in view of possible improvements

To strenghten IT skills and capacities in demographic analysis of the staff working on vital statistics also in view of improving dissemination of information



Recommendations – Vital statistics

To continue collaboration with data providers, also in the Interagency WG in order to:

- improve the coverage of vital events registrations, targeting more problematic areas in the country
- reinforce the network of reference persons in ministries
- raise awareness about the relevance of statistics among civil register officials
- agree on the transmission of the Unique identification number in every vital event record and possibly the inclusion of new variables (e.g. country of birth)
- evaluate the quality of information about causes of death, still births and neo-natal mortality

Road map and time plan - Vital

Next mission on vital statistics: 8–12 February 2016

- Review of data collection and discussion on how to handle electronic data (finalizing the document on data processing)
- Meeting with data suppliers (data quality, possible new information)
- Review of methodology (analysing data on undercoverage, suggesting improvements in data editing)

NSSRA is expected to (homework):

- Have specifics about the on-line acquisition system (from VXSoft)
- Prepare the document on data processing
- Further elaborate census data on undercoverage



Conclusions - Migration statistics

- Estimation of the quality of main indicators have been discussed.
 Need more time to estimate.
- Good relations with State Migration Service. The agreement can be signed including cooperation, methodological consultation, description of providing data, data format, metadata issues.
- Good relations with Visa and Passport department of the Police of RA. According to the RA Government Decree on Defining the order of providing data to the National Statistical Service of the RA from the Information System of State Population Register the information about population movement have been provided to NSSRA. Data editing, imputation procedures is needed to be documented.
- The RA Government Decree could be updated including the provision of the additional required data.

Recommendations - Migration statistics

• To analyze the possibility to use the mirror migration data for estimation the tendency of quarterly international migration data;

• To analyze the possibility in the Integrated Living Conditions Survey to ask questions about movements (except purposes of movement) for all hh members (from 0 age);

• To use the reweighting procedure in Integrated Living Conditions Survey for receiving the better quality of the results.

 Some partial imputation for the data about personal movements from the State Population Register should be done.

• Very important to receive the detailed data from the Border Management Information System. Meeting is needed.

Road map and time plan – Migration

Next mission on **migration statistics**: May 2016

- reviewing the methodology of the survey, continuing the cooperation with data suppliers.
- NSSRA should prepare (homework):

 Detailed methodology documentation, specification for defining the internal migrants, emigrants, immigrants, population number by different breakdowns

-Deadline: April 2016

 Organize different meetings with National Security Service of RA and Ministry of Foreign Affairs

- To reflect on the best IT tools to be used for data processing and analysis
- To identify experts that can provide training to internal staff
- To have a (internal or external) training courses of Survey Sampling theory, Statistical data analysis;
