Household Questions regarding agriculture

Question, Ch. 1

IF THE HOUSEHOLD FARM CULTIVATES THE AGRICULTURAL CROPS ON THE PLOTS MANAGED BY THE HOUSEHOLD (OWN, INCLUDING HOUSEHOLD PLOT AND LEASED PLOT; WITH FEE OR WITHOUT) OR DEALS WITH ANIMAL HUSBANDRY, REGARDLESS WHETHER THE PRODUCED PRODUCT IS ANTICIPATED FOR OWN CONSUMPTION, SALE OR ANY OTHER PURPOSES.

"Yes" should be underlined, when the given household farm cultivates any type of agricultural crops on the lands managed by the household (own, including household plot and leased plot with or without fee) or deals with animal husbandry (keeps any type (s) of agriculture livestock regardless its number, gender and age), regardless whether it is for own consumption, sale or trade, as well as if the household has agricultural lands, which are not utilized for operational (designated) purposes.

Otherwise, the answer "No" should be underlined in the relevant cell.

Question Ch.2.

NUMBER OF AGRICULTURE LIVESTOCK (HEAD) BELONGING TO THE HOUSEHOLD

The question regarding the number of agriculture livestock of the household includes data related to the number of agriculture livestock in the relevant rows, according to the livestock types.

In the row "total Cattle" the total number of all cattle types (cows, producing bulls, oxen, heifers, calves up to 1 year, etc.) belonging to the household is included.

In the row «from which – cows» the total number of all the cows belonging to the household is included.

In the row «from which – buffalos» the total number of all the buffalos belonging to the household is included.

In the row «from which – pigs» the total number of pigs of all gender and age groups belonging to the household is included.

In the row «from which –sheep» the total number of all types of sheep of all gender and age groups belonging to the household is included.

In the row «from which – goats» the total number of all types of goats of all gender and age groups belonging to the household is included.

In the row «Poultry» the total number of all types of poultry of all age groups is included (hens, turkeys, ducks, geese, quails, ostriches and other poultry).

In the row «Hive-beehive» the total number of the beehives according to unit quantity is included.

QUESTION, Ch. 3

LANDS OWNED BY THE HOUSEHOLD (CULTIVATED OR NOT) INCLUDING THE LEASED LANDS

(hectares` 0.00 accuracy)

In the row "Agriculture lands" the total number of all land plots belonging to the household (including the leased) is included. Agriculture lands are the lands used for production of agricultural products. Arable lands, lands with permanent crops (perennial plantations), hayfields and pastures are also included in the agriculture lands.

The measurement unit should be fixed in hectares (for example: 500 sq.m = 0.05 ha, 600 sq.m = 0.06 ha 1000 sq.m = 0.1 ha, 20.000 sq.m = 2ha)

In the row "Arable lands" the total number of all lands belonging to the household (including the leased lands), including lands for agricultural crops, perennial forage crops, grass and fallow lands is included. This row also includes the arable land, which has not been utilized by the household for agriculture crops, but the grass (forage) was collected from it or it has been used for pasture purposes.

In the row "Perennial plantations" the territory of all perennial plantations (perennial plantations are the lands with fruit-bearing gardens, berry fields and grapevine gardens, regardless whether they are new or at the bearing age, as well as the lands used for seed-plots) belonging to the household (including the leased lands) is included.

In the row "Fruit –bearing garden and berry fields" the territory of all fruit-berry gardens and berry fields belonging to the household (including the rented lands) is included.

In the row "Grapevine gardens" the territory of all grapevine gardens belonging to the household (including the leased lands) is included.

In the row "Natural plough-land" the territory of natural plough-land (all lands used for hayfields) belonging to the household (including the leased lands) is included.

In the row "Pastures" the territory of pastures (all land plots used for grazing and not for hayfields) belonging to the household (including the rented land plots) is included.

In the row «Household plot» the territory of the household plot belonging to the household farm is included.

Question, Ch. 4.

FISHING, FISH FARMING OF THE HOUSEHOLD FARM (PRODUCTION OF AQUACULTURES)

«Yes» answer is mentioned when the household farm deales with fishing, fish farming (production of aquacultures), excluding decorative (aquarium) fish farming.

This field includes fishing of shellfish, craw, crab, lobster, shrimp, crayfish, clam, turtles and other aquacultures fishing in internal coastal freshwater, as well as fish farming, climate adaptation of fish and fish ameliorative activities` new small fish, frogs, seaweed and other seafood farming.

Otherwise the answer «No» should be mentioned in the relevant row.
