3 Business Register

Statistics Finland maintains a Register of Enterprises and Establishments and a Register of Public Corporations. The Business Register provide information from the service database formed of the Register of Enterprises and Establishments. It covers all enterprises, corporations and self-employed persons that are liable to pay value added tax or have paid employees. The Register of Public Corporations contains all central government agencies, municipalities and joint municipal boards.

The Business Register data include enterprises' addresses, branches of industry, size categories of personnel and turnover, dates of establishments and importer/exporter data. The data can be derived on both enterprise and establishment levels. The data sources of the Business Register are several administrative records and Statistics Finland's direct inquiries to enterprises.

3.1 Services

Addresses and other data

Address and extensive detailed data on individual enterprises can be selected by diverse criteria.

Supplementing and updating of customer files

The customer's own files can be supplemented by mechanise, for instance with data on industries, size category of personnel or turnover. New target groups can also be updated to the customer register on the basis of industry data already available in the customer database.

On agreement, the enterprise and establishment data supplied can be updated at desired intervals. Information from the Business Register is supplied as lists, diskettes and CD-ROMs.

Statistical analyses and studies

Analyses of the customer's own registers and tailored studies based on the material in the Business Register, for example on enterprises by area, industry and size category.

3.2 Service registers

We provide information from the following service registers:

Business register

The statutory duties of Statistics Finland include the operation of a Register of Enterprises and Establishments. The public data in this basic statistical register can be used for marketing and many other purposes. The register covers all enterprises, corporations and self-employed persons that are liable to pay value added tax or have paid employees. Public authorities are not included. The register is updated continuously. The data derive from Statistics Finland's own surveys and from various administrative records.

There is a special service data file based on this register, which contain approx. 300,000 operating enterprises and corporations and approx. 337,000 establishments. Monthly updating of the main items ensures the timeliness of the information on start-ups, postal addresses, etc.

Data on the names, addresses, business identity codes, industry branches, etc., can be derived from the register and used for example in customer register functions and for marketing purposes. The data can be ordered by branch of industry, by location, or by size of unit, and are delivered either as paper printouts, or on diskettes, CD-ROMs or by e-mail.

This guide gives you information on our services, the data contents available and on the various data classifications. The statistical tables at the end of this publication list include for example the number of establishments by branch of industry.

Register of public corporations

The Register of Public Corporations covers all central and local government authorities and their establishments, the number of establishments totalling approx. 30,000. The data content of the register is similar to that of the Business Register, except for the turnover data, which are not available on public corporations. Each municipal unit has been assigned a code according to the relevant category of accounts under the municipal budgetary scheme.

Enterprise group register

The enterprise group register contains information about group relationships, links between parent and subsidiary companies and parent and partly-owned companies. Public enterprise group data make it possible to select address information for enterprises owned by foreign enterprise groups, for example.
