Executive Summary

Status of the SBR

Based on a presentation by the SBR team and the discussions during the mission, the consultants concluded that despite the reduced resources due to the population census the SBR was still moving forward and continuously improving.

Revision of five-year plan

The work plan was evaluated and revised adding a few new points, revising a few and removing some from the plan.

The revised five-year plan needs to be presented to users and management for endorsement.

Work plan 2015

From the revised five-year plan the SBR priorities for 2015 were identified as

- The quality report
- Develop methodology on institutional sectors
- Survey on SBR unit including entrepreneurs to improve data quality within SBR
- Promote use of the survey side
- Develop methodology for business demography
- The SBR rulebook
- Establish regular meetings with users

The work plan 2015 needs to be presented to users and management for endorsement.

Institutional Sector (ESA 2010)

An initial discussion on introduction of Institutional Sector in SBR was taken with participants from National Accounts (NA) representing BHAS, FIS and RSIS as well as the SBR team.

The possible technical changes to the SBR were identified according to NA requirements.

Quality report

The methodology of the quality report was discussed and the main areas to focus on were identified as the quality of activity codes and status of activity. These were the most important from the user view.

Quality measurement survey

The conditions and principles of a quality measurement survey were discussed. Such a survey will not be done in 2015 since a data improvement survey will be done.

Use of survey side – in statistical work plan 2015

It is important to get surveys to use the surveys side of the SBR and a way to get the process started was discussed including drawing up a schedule, and use the regular user meeting to promote the use.

Regular meetings with users of SBR

The consultants emphasized the importance of user meetings and strongly recommended to establish them as more than ad hoc meetings.

1. General comments

This mission report was prepared within the Twinning Project "Support to the State and Entity Statistical Institutions, phase VI". It was the first mission to be devoted to Business register within Component 2 of the project.

The purposes of the mission were:

• Assessment and status check since last Twinning project. Updating of the 5-years development plan. Quality of the SBR.

The consultant would like to express their thanks to all officials and individuals met for the kind support and valuable information which they received during the stay in Bosnia-Herzegovina and which highly facilitated the work of the consultant.

This views and observations stated in this report are those of the consultant and do not necessarily correspond to the views of EU, BHAS, FIS, RSIS or Statistics Denmark.

2. Assessment and results

Status of the SBR

The SBR team gave a presentation of the development and current status of the SBR which is included in annex 3.

Not all planned activities in 2014 were achieved, among other things because of the population census in BiH that drained a lot of resources away from other development.

The consultants concluded that despite the reduced resources the SBR was still moving forward and continuously improving.

Revision of five-year plan

The work plan was evaluated and finished items were removed from the plan.

New items and changes in the form of removal of items or changes in scope or content of items were discussed intensively and a revised five-year was agreed upon.

The changes to the five-year plan are listed in the table below.

Work plan 2015

From the revised five-year plan the SBR priorities for 2015 were identified as

- The quality report
- Develop methodology on institutional sectors
- Survey on SBR unit including entrepreneurs to improve data quality within SBR

- Promote use of the survey side
- Develop methodology for business demography
- The SBR rulebook
- Establish regular meetings with users

Besides these priorities all the continuous tasks involved in keeping an updated, high-quality SBR for the benefit of efficiency and quality of business statistics will be done. The 2015 priorities are indicated in the five-year plan in annex 8.

The work plan 2015 needs to be presented to users and management for endorsement.

Institutional Sector (ESA 2010)

An initial discussion on introduction of Institutional Sector in SBR was taken with participants from National Accounts (NA) representing BHAS, FIS and RSIS as well as the SBR team.

The Danish approach to the implementation of the Institutional Sector in SBR was presented. In Statistics Denmark the sector code is coded in the SBR based on NA rules. The vast majority of units are thus coded automatically and only a few cases are left for the NA to code manually. The NA in BiH agreed that they should do it in a similar way in BiH.

It was agreed that NA should defined rules that can be implemented in SBR for the maintenance of sector codes. All border cases that need manually coding are NA's responsibility.

In Denmark the sector codes are derived from the main branch at both enterprise and local unit. NA agreed that this could be an idea.

In the current data model for SBR allocating sector codes on LU's is not possible. To implement this, a change in the data model must be done.

There may also, in a few cases, be a need for more than one sector code on the local unit. There are several solutions to this, but first the need has to be clarified. The need and importance of multiple sector codes on LU should be balanced with the cost of implementation. If it only affects a few units with very limited consequences in the NA, it might be too much trouble to make the necessary changes right now in view of other more important needs.

The need for multiple sector codes on local units in BiH should be assessed before the next mission on institutional sectors, as it requires a change in the data model. It is necessary to assess this part before the mission to have a focused discussion on the actual requirements rather than discuss theoretical requirements.

Also it is a good idea to examine the need for different codes on enterprise and local units before the next mission on this topic in October 2015.

The real issue with multiple sector codes on LUs is that the LUs in the SBR are not real LKAUs. That is, the LUs are only places of activity for the enterprise and not split between the different kinds of activities taken place at the LU. This is a pragmatic solution to the over registration of activities in the administrative sources. In the administrative data every activity

that takes place however small is registered on individual legal LUs (LeLUs). This means that on each address there might be 10, 20 or even more LeLUs with far less employees.

The normal principle in SBR is that employees are not split between activities; that activities that are necessary to do the main activity should not be registered separately; and for an activity to be registered separately, it should provide its services to a market. For example we take a hotel with a breakfast restaurant. The hotel is the main activity and the breakfast is an integral part of running a hotel even though part of the staff is only employed for the purpose of the restaurant, e.g. the kitchen staff. If however the restaurant was open to all, it would be a separate activity on the same location and staff needs to be split (statistically) between the two LKAUs.

This is the correct approach according to the SBR manual but a different approach is taken in BiH of pragmatic reasons. However if there is a recognised and important need to create real LKAUs then it would require

- Changes in the data model to allow for multiple LUs or LKAUs on same address with different kinds of activities
- Changes in the rules that creates LUs (or in this case LKAUs) from administrative sources
- Use of SRS data on employment (includes personal id making separation between activities possible)
- More manually processing in order to validate the results
- More quality improvement surveys on LKAUs to ensure the correctness of kind of activity, location and employment

A simpler and cheaper solution in the short term is to allow multiple sector codes on LUs manually coded by NA. The division of employees and turnover must also be registered.

Quality report

A presentation on the Danish quality report was made. A Danish paper, in English, on the subject is available at www.statistik.at/wiesbaden2014.

To measure quality, it was agreed that a picture/frozen version per 31-12-20xx was made each year and changes were then to be measured against the picture from the year before.

It's important to get started on making a quality report. It may be a good idea to start with a few tables on the things that are most important to the users. Tables should be repeated for several years to insure consistency in the measurement but there are no problems in expanding the number of tables.

In annex 9 a few examples of tables are presented as inspiration to the quality report.

All tables should have a comment between "no comments" to a focus on development, normally not more than 10 lines.

The quality report should contain an initial paragraph with some general comments about the SBR's quality.

The Quality report should be presented on a User group meeting and after that published on the Intranet.

Quality survey

In order to provide additional information on the quality of SBR to the users it is recommended to do a quality survey in 2016.

The quality survey will provide a benchmark to the quality report to measure quality improvements against.

A data improvement survey is to be implemented in 2015 and having two separate questionnaires on the same topic in the same year will not be feasible.

In annex 6 some considerations on the setup is presented.

Specific topics discussed

Survey on employment data on local units

There was a discussion on whether to do a special survey on employment on local units. SRS data are supposed to cover this but since it is not included in the data exchange in RS and district of Brčko and only 4,000 LUs out of 29,000 LUs were covered in FBiH the information is still not available in the SBR.

It was recommended that the statistical institutes examined whether any statistics needed the information to perform their surveys or if it is only nice to know. If it is the first, then the question is how they manage today and if a survey will improve the situation and if it is the latter, it is better to focus the resources on getting better data from the SRS.

Financial data on entrepreneurs

RSIS had examined data from the Tax authority to assess the possibility of using personal income from entrepreneurs to get turnover on entrepreneurs in the register.

The available data was on the level of owner, i.e. if one person owns more units, each considered individual enterprises in the register, the financial information cannot be split between enterprises.

A solution could be to consider all units personally owned by a single person to be one unit or enterprise.

Revision of municipalities

RSIS informed that in connection with the population census a revision of the municipality division was done resulting in a revised value set for municipalities. The entities agreed on a common update of the new value set on December 31th.

Use of survey side – in statistical work plan 2015

In RSIS six surveys were using the survey side of the SBR. It was not used in either FIS or District of Brčko. Surveys not using the survey side received samples frames in Excel sheets and returned feedback and corrections in Excel.

It was discussed if use of the survey side should be promoted or abandoned.

It was recommended that

• The survey side should be used because it presents advantages to both surveys and SBR

- The SBR should list the advantages to sell the use to management and survey staff
- A schedule should be drafted in which all parties (starting with head of sector) committed to introduce e.g. three statistics into the survey side in 2015. In the following years the number should be increased until all surveys use the survey side
- The process could start with the most willing but it is important to signal that all surveys needs to use the survey side and at some point a certain amount of pressure might be necessary
- The schedule should be included or referred to in the general statistical work plan to ensure enough focus on the process

Regular meetings with users of SBR

Meetings with SBR users were ad hoc meetings depending on special topics that needed to be discussed. Meetings with individual surveys take place when they are introduced to the survey side of the register.

The individual meetings are important but in addition frequent general meetings with the users should be prioritised.

The purposes with regular meetings with users of SBR is to

- Inform users of changes and improvements
- Prioritise development according to needs of surveys
- Establish rules governing the SBR
- Give input to and agree on work plan

As inspiration for the meetings a draft agenda is included as when as topics for future meeting in annex 5.

Data confidentiality

In view of a discussion on the possibilities of disseminating or exchanging data on the level of individual enterprises, the consultants recommended in line with EU-regulations, that no sensitive and statistical data on the level of identifiable units should be shared outside the statistical system. The statistical system of BiH is the three entities/district and BHAS and could if define as such at the appropriate level include other producers of statistical information like the Central Bank.

Data collected by surveys and financial/employment data from administrative sources should always be treated as confidential whereas already public available data could be considered non-sensitive. Whether the statistical activity code is to be considered sensitive might be different from country to country.

The rules on who can gain access and how and on what aggregation level access can be granted should be part of a general data confidentiality policy for the statistical system. Such a policy should be developed and endorsed at top management level and published at the official websites.

In other countries including Denmark a special access to anonymised micro data are available to researchers from recognised research institutes.

Double/detailed history

It was raised from the SBR group that it could give better quality if they, as we have in Denmark, introduced double history. Double history is the principle of registering both when a change occurred in the real world and when information was registered in the SBR.

The Danish consultants contacted the Danish expert Søren Netterstrøm, who was deeply involved in designing the data model. The Danish experts on this mission and a it-architect in SD also looked at the data model.

All agree that the data model can be changed. But it will require some adjustments in the data model. Adjustments which, depending on the IT staff experience with double history, will take 2-6 months. It will be beneficial if BiH received external support to initiate such a change. In addition to the data model, it will also cause changes in the update rules. These should also be described and developed. All in all the change would not be less than a year's work (it is a very rough estimate).

All agree that it is not a priority now, but should be a topic at the next five year work plan.







What we in fact have is that for each unit we have a base-unit, that contains ID, starting and cessation data. Then we have the data part that has a day of change, so we keep the history that way.

It seems to be on the data unit you would need to expand with the four days mentioned above, but it may need further considerations.

For the update procedure there will be some changes need. Assume we have the following data in the register for a unit

Note that both records are still valid in the register, as they record the current view on the period in real time

I have no overview of the number of procedures that may need a change, however, when done for one type of unit, the same model applies to other types of units, so once solved the solution can be reused.

When it comes to the online system, I assume that the normal thing is you look at the current register content (Register end date = NULL) bit may have the option of asking for another day, i.e. I like to see the register as it looked on Jan. 1. 2014. Then at least you may still be able to navigate. It mainly requires modifying all the queries to include this selection.


