

0. Executive summary

The key objectives of the mission was to follow up on the recommendations given during the E.4 mission, to review the progress achieved of the activities indicated in the Road map for the Component as well as to discuss the treatment of seasonal products and quality adjustment methods applied for the compilation of the CPI.

Participation in the Training workshop on HICP for Regional Statistical Agencies and external stakeholders was another important activity carried out during the mission.

It was agreed that NSSRA would continue the implementation of the methodological and technical solutions applied by the EU MSs for the compilation of the HICPs in the national CPI production environment.

Appropriate documentation reflecting the work carried out during the EU Twinning Project period will be prepared till December 2012.

After discussions on the method used for the estimation of prices for the seasonal products in the outof-season period, it was noted that some improvements could be considered. Some progress has been achieved for the application of quality adjustment methods since the previous mission. However, further development in this area is welcome.

The final agreement on the organizational issues of the Training workshop was reached.

1. General comments

This Mission Report was prepared within the framework of the EU Twinning Project. It was the fourth mission and additional activity (as compared to the original contract) E.4.2, Training workshop on HICP for Regional Statistical Agencies within Component E: Introduction of the Harmonized Consumer Price Index.

The main objectives of the mission were in line with ToR and were as follows:

- Follow up on the Road map for the Component as specified in the E.4 Mission Report;
- Advice on on-going sub-projects related to the development of the CPI/HICP (in particular, treatment of seasonal products and treatment of quality adjustment methods);
- Participation in the Training workshop for Regional Statistical Agencies and external stakeholders:
 - ✓ Present and discuss the differences between the national CPI and the HICP;
 - ✓ Present the Latvian and Lithuanian experiences on introducing the HICP;
 - ✓ Advice on the re-organization of price collection.

The MS Experts would like to express their heartfelt thanks to all officials and individuals met in the NSSRA for the kind support and valuable information which they received during their stay in Yerevan and which facilitated their work.

The views and observations stated in this Mission Report are those of the MS Experts and do not necessarily correspond to the views of Statistics Lithuania or Central Statistical Bureau of Latvia.

2. Assessment and results

Current status, progress and developments since the last Activity E.4

The Head of the Price Statistics and International Comparison Division of the NSSRA presented the progress achieved since the last meeting in April 2012. The work planned and presented by the EU Experts in the fourth Mission Report was reviewed activity by activity. The analysis of the impact on the CPI for the city of Yerevan, after reducing the frequency of price collections within the same month, had been continued. Calculations had been carried out till June 2012. The documentation of the current approach on the treatment of seasonal products in the Armenian CPI and quality adjustment procedures is at the preparation stage. The staff of the Price Statistics and International Comparison Division carried out the reclassification exercise of the goods and services according to the COICOP/HICP classification. The preparatory work for the extra activity – a Training workshop (for price collectors and external stakeholders) – had been carried out. The study visit to Statistics Denmark by three BC experts had been carried through.

Discussion on the agenda and the presentations for the Training workshop

The preliminary agenda of the Training workshop was discussed with the project's Resident Twinning Adviser (RTA), Mr Thomas Bie, and during a briefing with the BC Project Leader, the President of the NSSRA, Mr Stepan Mnatsakanyan and the Head of the Price Statistics and International Comparison Division of the NSSRA, Mr Gurgen Martirosyan. The content of the presentations prepared by the EU Experts was considered and accepted by the RTA. Organisational issues were discussed as well and the final clarification of the topics included in the agenda was made. Special attention was paid to the issue regarding the group discussions on topics related to the reorganisation of the price collection.

Discussion of the interim estimation of the HICP issue; further advice on the quality adjustment methods

The future development of the system for the interim compilation of the HICP by the NSSRA was discussed. The weights of 2010 will be used for the calculation of the interim HICP. These weights, classified according to the COICOP/HICP, will be price-updated to December 2011 and will be used for calculation of price indices for 2012. The price and index reference period will be December 2011. Some modifications of software, necessary for the compilation of the interim HICP, will be discussed during September with the Information Technologies Development Division staff of the NSSRA.

Armenian colleagues presented the quality adjustment methods and procedures used for specific products. The CENEX Handbook on the application of quality adjustment methods in the HICP was used as a reference document to decide on the methods that could be used for specific cases. The following methods are mainly used in practice: package size adjustment, direct price comparison, overlap, bridged overlap, option pricing and judgmental quality adjustment. The issue concerning the stratification of product brands was discussed. It was recommended to implement brand stratification applied in the PPP Programme for certain product groups. The proposed approach facilitates the adjustments due to quality changes. The importance of distinguishing between minor and major characteristics of the product was stressed during the discussion.

Treatment of seasonal products

Armenian colleagues introduced the EU Experts to the procedure on treatment of seasonal products in the CPI. Seasonal products are divided into two groups: 'strong' seasonal and 'weak' seasonal products. 'Strong' seasonal products are those which are not available for purchase and for which prices can not be observed for a certain period of time during the year. 'Weak' seasonal products are those which are available for purchase and which prices can be observed throughout the year but the price level and quantities sold vary significantly during the year.

In the out-of-season period the price is estimated by the price movement of the group to which the product belongs starting from the first month of the out-of-season period. It is assumed that the season starts when product is available in 50% or more settlements where prices are collected. Weights are kept fixed during the year. The procedure presented was discussed in detail and some recommendations concerning the use of the typical price in the first month of the out-of-season period as well as some technical solutions for the first in-season month were given by EU Experts.

Reorganisation of the price collection procedure

The specific road map for reorganisation of the price collection procedure in Armenia that was elaborated by EU Experts together with specialists of the Price Statistics and International Comparison Division during the E.4 mission is still in force. The main activities should be carried out till the last EU Experts mission (Activity E.6 Review of the implementation).

Mr. Gurgen Martirosyan presented some ideas on the reorganisation. The number of price collection will be reduced from three to two, number of outlets and products will be reviewed, the burden of price collectors will be reduced and responsibilities rearranged. EU Experts stressed the need for analysis and evaluation of workload for price collectors.

Training workshop on HICP for Regional Statistical Agencies

The additional activity within the framework of the Twinning Project – a Training workshop – was held on the third day of the mission. Price collectors from the Regional Statistical Agencies, Heads of Regional Statistical Agencies as well as representatives of international organisations and external stakeholders participated in the workshop. See list of participants in Annex 3. EU Experts made the presentations regarding the HICP and shared their experience on the implementation of the HICP, price collection procedures, and data quality assurance. EU Experts and the staff of the NSSRA gave answers to questions raised by participants of the Training workshop. Mr. Gurgen Martirosyan presented the analysis on the reduction of price collection and introduced the re-organisation plan of the price collection.

It is necessary to stress that the workshop was well organised and positively evaluated by price collectors. Fruitful discussions took place and representatives from Regional Statistical Offices expressed their opinion on the issue concerning reorganisation of price collection procedure and presented their problems.

Other issues

The briefing with the BC Project Leader, the President of the NSSRA Mr Stepan Mnatsakanyan took place during the mission. The findings, conclusions, recommendations and actions to be carried out before the next Activity E.6 were presented and discussed. The workshop agenda was discussed as well.

3. Conclusions and recommendations

The analysis of the impact of the reduced number of price observations to the annual rate of change, prepared by NSSRA specialists, shows once again that reduction of the frequency of price collection from three to two per month has a negligible effect. It was recommended to continue the pilot calculations of the CPI till the end of 2012 and analyse the impact to the CPI for Yerevan.

Further implementation of the quality adjustment methods should be carried out. Documentation of quality adjustment procedures should be continued.

The work on the implementation of the COICOP/HICP classification in the price statistics environment will be further carried out. It was recommended to analyse carefully the COICOP/HICP categories which presently are not included in the CPI and, if it would be necessary, to extend the coverage of products and outlets.

It was recommended to make more efforts to start some calculation of the interim HICP till the end of 2012.

Further technical assistance and advice on the transposition of EU legislation into the national statistical environment would be needed for the NSSRA.

In order to improve the quality and comparability of the CPI the NSSRA should continue implementing the minimum standards for the HICP in statistical environment.

4. Actions before next activity (E.6)

The next activity within the Component E is the final one - Reviewing mission E.6 that will take place possibly in the beginning of December 2012.

It was agreed between the BC and MS Experts that the most of the work and actions already defined are in force and should be undertaken and documented before the final activity:

- To continue the analysis of the impact to the CPI for Yerevan after reducing the frequency of price collections per month;
- To review the Armenian CPI products and outlets sample in order to assess the consumption categories of the COICOP/HICP, which potentially should be included in the HICP coverage;
- To document the work carried out (written material; have it translated into English):
 - ✓ on the implementation of the quality adjustment procedures;
 - ✓ on the implementation of the COICOP/HICP classification;
 - ✓ on the compilation of the CPI weights;
 - ✓ on the treatment of seasonal products in the CPI.
- To prepare a Quality Declaration for the HICP as a part of the documentation procedure;
- To prepare a detailed plan for reorganisation of the price collection process (preferable written material; have it translated into English);
- To prepare a short report on the progress achieved before the Reviewing mission E.6 (*written material; have it translated into English*).

It has been agreed that the documentation should be available for translation approximately one month before the last activity, E.6. The structure of the documentation will be decided upon in the beginning of September 2012.

The Road map that was updated during the E.4 mission (see E.4 Mission Report, Annex 5) was studied in the light of the above mentioned work tasks, and the Road map remains unchanged.

EU consumer price index to be introduced in Armenia

On 13 July 2012 the National Statistical Service (NSSRA) and the EU project "Forwarding Armenian Statistics Through Twinning" will organize a workshop on the introduction of the European Union's "Harmonized Consumer Price Index" (HICP) in Armenia.

As the official measure of inflation, the consumer price index is a key statistical indicator. All countries in the European Union publish both the HICP and national CPIs. The introduction of HICP in Armenia is an important step in adopting EU standards, and will probably happen in the beginning of 2014. Most of the changes in the data collection, however, will start from the beginning of 2013, while the re-classification of consumer goods and services is already in process. The data will be used to establish the expenditure weights for the HICP.

The workshop will be conducted both involving stakeholders and professional users of the consumer price index and will focus on the differences between the two indices, their scope as well as their specific uses. An important part of the agenda is the re-organized data collection in relation to the existing national consumer price index. An analysis of the implications of this change in methodology will be presented and discussed.

The workshop is organized with the participation of EU Experts from Statistics Denmark, Statistics Lithuania and the Central Statistical Bureau of Latvia.

The 2-year EU Twinning Project "Forwarding Armenian Statistics Through Twinning" focuses on harmonizing a range of Armenian statistics with European Union standards.
