#### 1. General comments

This mission report was prepared within the EU Twinning Project "Further Support to the Reform of the Statistics System in Bosnia and Herzegovina". It was the fourth mission to be devoted to the Component 5, Methodology for the compilation of the Monthly Balance of Payments, of the Project.

The purposes of the mission were:

To discuss the CBBH work on:

- the establishment of an internal registry of data sources for the compilation of monthly BoP
- the methodology for the production of monthly BoP
- the preliminary monthly BoP report against the rest of the world for a determined time period produced and discuss delivery to Eurostat
- the final plan for the introduction of the geo-distribution in the compilation and reporting of monthly BoP

The consultants would like to express their thanks to all officials and individuals from Bosnia and Herzegovina met for the kind support and valuable information, and which highly facilitated the work of the consultants.

This views and observations stated in this report are those of the consultant and do not necessarily correspond to the views of EU, CBBH, Statistics Denmark and Statistics Finland.

#### 2. Assessment and results

The CBBH BoP staff presented the consultants with the work produced since mission 5C. CBBH have drafted a methodological note on monthly BoP production, established an internal registry of data sources for the compilation of monthly BoP and made a final plan for the introduction of geographical breakdown in the monthly compilation of BoP.

The draft methodological report "Notes on methodology for the production of monthly Balance of Payments" is a thorough description of the methods used in the compilation of monthly BoP in CBBH. The structure is organized by BoP items that are required in the monthly data transmission defined in BoP Vademecum. The draft note was discussed among participants and as a result some modifications and clarifications were made based on the conversations had. The resulting note final methodological note is enclosed in annex (not publicly available).

The internal registry of data sources is in text format. Sources are divided to four groups: direct surveys, statistical and administrative sources of data and statistics compiled in the CBBH and ITRS. The registry includes the frequency of each data source. CBBH conducts six direct surveys to compile BoP statistics. The frequency of the surveys is either annual or quarterly or a mix of those. Statistical and administrative data sources cover a variety of different kind of data. It includes data from local government, statistical offices of BiH and other countries, international organizations and commercial data sources. In total sixteen different sources are mentioned with their frequency. Four external CBBH statistics, which are available on monthly or quarterly frequency, are used in BoP compilation. ITRS is a monthly source used in BoP compilation.

The plan for geographical breakdown is in the format of a table (appendix, not publicly available). It includes the required geographical breakdown, the planned data source along with comments on methodology by BoP item. The requirements vary between geo1 and geo3 breakdowns, as presented

in the monthly BoP requirements. Geo1 breakdown is simply the rest of the world as a sum, whereas geo3 additionally includes a breakdown to euro- and non-euro area as well as EU- and extra-EU. The geographical breakdown is needed for nine BoP items in credit and debit and in addition to 3 items in credit only. The plan indicates that monthly data including geographical breakdown is used where available. Where no monthly data is available, modelling or information from previous time periods is used. The consultants and the CBBH staff worked on the plan during the mission and clarifications and additions were made.

CBBH staff informed the consultants that they have the readiness to transmit the reporting table according BoP Vademecum monthly requirements on geo-level 1 to Eurostat as soon as they are informed on the delivery format and deadline.

#### 3. Conclusions and recommendations

The goals for the final mission were fully met. CBBH staff presented the consultants with an internal registry of data sources for monthly BoP, final plan to create a monthly geographical breakdown as well as a note on methodology. All documents were covered in conversations during the mission and modified accordingly.

The methodological report "Notes on methodology for the production of monthly Balance of Payments" gives reader a comprehensive description of the methods used in compilation of monthly BoP by CBBH. The structure is clear and it includes the elements needed to meet the international requirements set especially for EU member states, EFTA countries and candidate countries. The consultants recommend that CBBH staff constantly reviews this document in terms of monthly BoP compilation and updates it when there are changes in methodology or sources used.

Additionally, the consultants would like to recommend that the internal registry of data sources be expressed by monthly BoP item in a similar format as the plan for geographical breakdown. This would further clarify the current state of preparedness to compile monthly BoP and will be useful in identifying room for improvements in the future.

Consultants recommend that CBBH keeps on their good work in the development of the monthly BoP production. It includes constant search for new data sources to be used and assessment and improvement of the methodology and models used. Special attention should be paid to sources that can catch sudden changes in data series in case of unexpected events.

CBBH staff will be informed by the consultants on the format and deadline of the data delivery to as soon as it is set by Eurostat.
