1. General comments

This was the fifth activity in component 3 and the actions planned for this activity were carried out as scheduled in the ToR, cf. annex 1 and the programme, cf. annex 2. The purposes of the mission were:

- To review final drafts quality declarations for the five economic surveys, the quarterly national accounts, the annual national accounts and a few other statistics
- To discuss how the upcoming population census can be presented in a quality declaration
- To discuss the online publishing of the quality declarations
- To review the experience from the training course
- To conduct a seminar with key external users where the quality declarations are presented

The consultants would like to express their sincere thanks to all officials and individuals met for the kind support and valuable information which we received during the stay in Jordan and which highly facilitated our work. The views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, DoS or SD.

2. Conclusions and recommendations

2.1 Quality Declarations

The Quality team has conducted a successful training course on quality work and quality declarations with some 25 participants. These have subsequently trained other staff.

Following this training, the QD Template has been implemented successfully for several statistics. Some of these had been translated and handed to the experts, who reviewed them, discussed them with the quality team and delivered proposals for amendments regarding 7 selected statistics. These proposals will be further considered by DoS.

Some issues, like sampling and sources and indicators of errors, needed further elaboration and would benefit from further enhancements, which were proposed by the experts.

Recommendations:

1. The Quality team (QT) should develop more comprehensive guidelines for content of each item
2. In particular the QT should develop & promote standard sentences, for the producers of QD, for some items, such as sources and accuracy
3. There should be links from QDs to statistics in all QDs (if there are any published on the web site)
4. Quality declarations should include the latest date of updating of the QD.

2.2 QD on the Census of Population

The experts had been asked to give recommendations on how to complete a QD for the Census.

A very good text is found on the DoS web site describing the Aqaba 2007 pilot census. This should be used as inspiration. But some aspects need further elaboration. The experts drew

attention to another source of inspiration, a quality declaration from Ireland on the 2006 Census. The experts delivered a sketch of a QD based on these two sources.

It is recommended that:

- DoS draws up a QD in the established QD format
- Publishes the QD progressively as the Census is carried out

2.3 Publishing the Quality Declarations

A test version of the DoS website for presenting QD was discussed. After a constructive discussion with the quality team and the IT-division the experts returned with a possible set-up for publishing QD on the DoS web site.

During Tuesday's session this set-up was presented, cf. annex 4. This short term solution is a swift way of making the DoS home page fit for QD. A long term strategy includes a database solution and is out of scope of this mission a will therefore be discussed in a forthcoming mission. The short term solution is to present QD in pdf format at a dedicated area on the home page.

The Quality team found the solution useful and agreed with the split in a short and long term strategy.

IT & Dissemination quickly developed and demonstrated a pilot of the dedicated area for QD on DoS web site following this model. The pilot was agreed to be very good. The Experts recommended that no later than 1.10.2014 the web site should be online with final versions of QD.

Further recommendations:

- Link to QD in Press releases
- Link to QD from tables and databases on the web site
- Release the pilot version of QD homepage, then editing the final drafts
- Suggested time line: no later than 1.10.2014
- Start with the QDs that are ready. Add QDs as soon as they are finished
- Long term: include QD in a comprehensive metadata system, to be further elaborated during next week's mission on metadata in the IT component.




Fig. 3: Work flow

The procedure for the work flow is outlined in fig. 3 below:

2.4 Updating QDs

During the review of the training course with the participants in the course, it was clear that the principles for updating the QD were not clear for them. It was pointed out by the Quality Division that each QD must be updated by the responsible statistician before publishing each new wave of the statistical product (e.g. Economic Surveys, Quarterly National Accounts).

There is a need for rules for this. The Experts recommend that these are established. It's recommended that the Quality team initiate this work. To monitor that QD are updated when figures are published, the experts recommend that date of latest update is shown in the QD.

2.5 Role of the Quality Team

The role of Quality team was also discussed. The Experts highlighted the importance of continuously working with elements of quality and develop an exhaustive strategy for their future work. Elements that are essential to be included in this strategy and in the work if the quality team are:

- continuously develop the templates and guidelines so they keep fit for purpose.
- follow/ monitor the ongoing work in the statistical division.
- create a link between management, statistical domains and Quality Division

In the short run it was recommended that the Quality team develop Standard texts for some crucial elements of the QD such as Sources and Accuracy.

This would improve and harmonize current and upcoming QD. Furthermore it will later on ease/reduce the work for the Quality team since the work load assisting the statistical divisions filling out the QD will be reduced.

2.6 Seminar with key users where QD was presented

Wednesday was dedicated to an all-day seminar with key users organised by the Quality team. To stress the importance of this work the Director General for DoS, his Excellency Dr.

Qasem Al-Zubi and also Mr Abed Wadood Matouk participated in the seminar. It was highlighted that dialog and quality work has a very high priority in DoS.

Also the RTA and Mr Lars Thygesen took the floor explaining the scope of the Twinning Project and stressing the importance of the work that is being carried out in DoS.

Mr Mohammad Khalaf, Head of Quality Division presented the work that has been carried out in DoS for this component. He focused on the work with the quality indicators, check list and the template for QD. This presentation was followed up by 3 examples of QD, one for each sector.

The participants reactions where very positive, and many used the opportunity to discuss specific problematic issues related to quality. Especially, the lack of a Business register in Jordan and consequences for quality for the samples drawn for surveys was raised by many.

The experts recommend that a strategy for developing a Business register must be prioritized by DoS.

The experts finally recommend developing a dissemination strategy with assistance from the Twinning.
