1. General comments

This was the eleventh activity in component 3 and the actions planned for this activity were carried out as scheduled in the ToR, cf. annex 1 and the programme, cf. annex 2. The purposes of the mission were:

- To discuss and evaluate that part of the DoS Quality Audit system not dealing with surveys, i.e.:
 - o User evaluation
 - Strategy accomplishment
 - o CoP evaluation
 - o External and internal website evaluation
- To discuss how the DoS Quality Audit system can be improved further
- To discuss how the components of the DoS Quality Audit system can be integrated into one common DoS Quality Audit system
- Presentation of the Danish and in general the European Union experience in quality auditing at the organization level

The consultants would like to express their sincere thanks to all officials and individuals met for the kind support and valuable information, which we received during the stay in Jordan and which highly facilitated our work. The views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, DoS or SD.

2. Conclusions and recommendations

2.1 Peer Review and Quality Assurance Framework

Statistics Denmark's experiences with the ESS peer review exercise on the implementation of the Code of Practice (CoP) and the possibilities for carrying out a similar review exercise in DoS were discussed. In this domain the experts have the following recommendations:

- DoS should make CoP and QAF well known throughout the organization; for each staff member the knowledge should correspond to the needs of his/her responsibilities. It is important that this knowledge should be widespread, so that all staff will know how to contribute to better quality within their own domain of work.
- Code of Practice (CoP) in Arabic should be provided and made accessible to all staff.
 - o A translated version has been supplied by Eurostat.
 - This version should be quality assured by DoS, and the result should be sent back to Eurostat for wider use.
- Translation of Quality Assurance Framework (QAF) version 1.1. in Arabic should be made in order to make this text accessible to staff.
 - o It has been agreed that this task can be carried out, financed by the Twinning.
- DoS should apply to Eurostat for a Peer Review
 - Ms Claudia Juncker of Eurostat has expressed willingness of Eurostat to accommodate such an activity.
- DoS should carry out a Peer Review in 2016
 - This activity is strongly sponsored by the Director General, which is key to success.

- The activity should involve almost all staff, and all staff should be made aware of the activity and its importance.
- The activity should be led by a Peer Review Steering Group chaired by a high level head in the organization.
- o The activity should be coordinated by the Quality Manager.

2.2 Organisation

- The Quality Division should have better access to the top management
 - o This is necessary in order to take quality into account in decisions.
 - The experts have taken note of the Director General's decision to change the organization to enhance quality, and this action would benefit the organisation's readiness to improve.

2.3 Culture and training

While the fundamental principles of CoP and QAF are well known in the quality team and in the quality division, the overall knowledge of quality concepts in DoS needs to be strengthened. In order to promote a culture in which quality issues are taken into account as an integrated part of the everyday work of DoS staff, the experts recommend that a number of activities are carried out with the overall aim to enhance awareness on quality in DoS:

- Prepare and carry out introduction courses for all new permanent employees, in which information is given about the general concepts of quality (such as timeliness, relevance, accessibility etc.) and statistics (such as overall concepts of sampling).
- Carry out a training course on CoP and QAF for middle management (Directors and Division heads). In order to be effective, this training should be sponsored by the Director General and should be carried out as soon as possible.

2.4 Quality assurance of the web site

Evaluation of DoS' website is necessary in order to assess basic quality principles of accessibility and clarity of statistics. An example of a user test video of Statistics Denmark's Statbank performed by <u>usertesting.com</u> was presented and a free user video test of the existing DoS website performed by usertesting.com was provided.

As DoS is currently preparing the launch of a new website, the experts recommend that a user evaluation of the website is carried out both before and after the launch of the new website (in order to have a benchmark). More specifically the experts recommend to:

- Perform evaluation of the old version of the web site:
 - By external users through usertesting.com (English) in which different kinds of users are given specific tasks to solve using the website. This can only be done for the English version of the website.
 - o A test of the Arabic version should also be carried out.
- Perform evaluation of the new version of the website:
 - o By external users through usertesting.com (English), in which different kinds of users are given specific tasks to solve using the website. This can only be done for the English version of the website.
 - o By internal users
 - By external users local as well as international users (e.g. international organisations)

• Once the new PC-AXIS database is launched the same procedure should be applied.

3.5 Auditing at survey level

In previous missions, quality audits for surveys have been discussed. This issue was also briefly discussed in this mission and the organisation and work processes for conducting such quality audits at survey level in Statistics Denmark was presented including processes for self-assessment, documentation, review, report and action lists. The experts recommend that:

DoS should decide on a method and organisation for carrying out quality audits at survey level. The quality audits should include the statistical domains and the Quality Division.

2.5 Reminder of old recommendations

The experts also reviewed recommendations from earlier missions within the quality component and found that many results had already been accomplished. However, the following recommendations were still valid and should receive attention in the near future:

- Link to QD from tables and databases should be established, so that users can easily get the relevant documentation when needed together with the statistics. This should be attended to as soon as the PC-AXIS database is launched on the web site.
- Rules for updating QDs should be established. A number of QDs were already live at the web site but it is important to ensure that they are updated whenever the contents or the quality of the individual statistics are changed.
- The Quality team must initiate this updating work.
- Date of last update of each QD should be shown in the QD, so the date should be added as a new item.
- It is still important for DoS to establish a dissemination policy, which puts all media and ways of dissemination together into one coherent picture and makes sure that they work together and supplement one another in a way that is helping the users.
