Executive Summary

1. General comments

This mission report was prepared within the Twinning Project "Support to the State and Entity Statistical Institutions, phase V".

The concrete objectives of the mission were:

- ➤ Discussions on how to prepare the future development plan for the production of the HBS (strategies and methods on creating and adoption of development planexperience from Finland and EU Members).
- ➤ Revision of questionnaires planning of future design and decreasing respondent burden. Relation with other surveys (LFS, etc.) Influence of future introduction and conduction of EU SILC survey in BiH (how EU SILC will affect the scope of HBS survey and decrease burden on HBS questionnaires in light of EU SILC).
- ➤ How to improve interviewing methods empirical examples from EU, open diary, computer assisted interview.
- ➤ Methods of staff recruitment and better efficiency of future interviewer training (special techniques of overcoming and decreasing non-response).
- > Methods for better future monitoring interviewers and supervisors.
- ➤ Harmonization of HBS with EU Methodology and Classifications
- ▶ Plan for future data analyses, publishing and documentation of following HBS.

2. Assessment and results

Introduction

The main objective of this mission was to assist the HBS staff to finalize the future development plan for the BiH HBS as well as to assist the staff to get agreement on HBS's future production strategy. On the other hand to increase understanding of the whole data collection process that is a very crucial stage in the whole survey process. How data collection process could be improved and strengthen especially from the minimization of non-response point of view. Alternative survey instruments, questionnaire design, interviewer training etc. have impacts on survey results and quality. Furthermore try to give a picture of ESS, what the European Statistical System is and evaluate what the present status in BiH in that regard is. One major issue was how the EU SILC possible could be integrated into the BiH survey system in future. Other topics discussed: measuring quality, quality reports, poverty measurement.

Current situation of the HBS 2011 production

Data editing and imputation (DEI) was done in cooperation with the Italian team (ISTAT) during the first half of current year so that the first preliminary report was published in July 2012. The final data consisted of 7400 households. Total consumption expenditure figures by COICOP were published as well as poverty rates based on expenditure figures in last July. Some minor logical data checks are still aimed to do during a study visit to ISTAT in next January. Standard error calculations will also be on agenda during the study visit.

Development plan and follow-up on the work done on HBS

New census is planned to carry out in BiH in 2013. The previous census was conducted more than 20 years ago. A new census will be a remarkable improvement in many ways. The new updated census data will be the sampling frame for all household surveys and will certainly help to solve problems caused by the under-coverage thus will improve the overall survey quality. The next HBS is scheduled for the year 2014. If the convergence between EU and BiH continues, also the BiH national statistical system should gradually be integrated into the ESS. Concerning ESS statistics on the distribution of income and on living conditions they are based on two data sources: HBS and EU SILC, hence there is the question how and when EU SILC should or can be launched in BiH. It should be included in the development plan and survey-program in BiH in near future.

HBS is based on Eurostat's so called gentlemen's agreement, but it is conducted in every EU-country anyway and HBSs are harmonized by Eurostat. EU SILC is the reference data source for statistics on income and social exclusion in all EU countries and it is based on a

regulation. EU SILC is conducted also in a number of non-EU countries for example in Iceland, Norway, Switzerland and Turkey.

The characteristics of the two surveys, HBS and EU SILC are different, but there are also overlapping elements like income variables. In connection of HBS 2011 a set of SILC questions were included in the HBS questionnaire. However it would be impossible in practice to merge those two surveys completely. Firstly that kind of system would be too massive to run on annual basis. The data contents would be too comprehensive and response burden would be heavy for the respondents that would cause high non-response figures. On the other hand there are also some technical reasons why HBS and EU SILC cannot be merged. HBS is a cross-sectional survey whereas SILC both cross-sectional and longitudinal. A part of the SILC households are interviewed in four consecutive years (panel) to be able to measure long-lasting unemployment for instance.

3. Conclusions and recommendations

The optimal solution could be, when EU SILC will be launched in BiH that HBS would redesigned, lightened and streamlined simultaneously so that there would be as little overlapping data collection as possible with SILC. HBS could be a survey focusing on consumption expenditures only and would be carried out about every five years whereas SILC data would be as it is, an annual, partly panel survey focusing on income distribution and living conditions.
