1. General comments

This mission report was prepared within the EU Twinning Project "Strengthening the Capacity of Georgian Statistical System". It was the second mission in Georgia within *Component 1.2: Statistics on International Trade in Services (ITS) compiled.*

According to the work plan for the component, the main objectives to be achieved during the mission 1.2.B were:

- Review of the ongoing work related to methodology
- Data collection process (drafting of solutions for issues identified in data collection and data validation)
- Analysis of existing administrative data sources, identification of potential new data sources
- Designing the questionnaire for a new ITSS survey
- Instructions for filling in the questionnaire

The consultant would like to express his gratitude to all officials and individuals met for the kind support and valuable information which he received during the stay in Georgia and which highly facilitated the work.

The views and observations stated in this report are those of the consultant and do not necessarily correspond to the views of the European Union, GEOSTAT, Statistics Denmark, or other statistical institutions involved in the implementation of the project.

2. Assessment and results

Review of the ongoing work related to methodology

During mission 1.2.A in August it was decided to add a screening question on international trade in services to Geostats business survey. This intention was, that the results from the business survey will be used as input for creating the final ITSS sample in summer 2020. During mission 1.2.B the results from the first round of data collection in the business survey (Q3) after the addition of the new screening question were analysed. Mainly, the analysis focused on the answers from units which are present both in the business survey and also in Geostat's survey on external economic activities. The analysis prepared by Geostat revealed significant inconsistencies between the answers to the business survey and the answers to the question on ITS in the survey on external economic activities. Therefore, it was concluded that improvements to the data collection and data validation remains a precondition for producing a strong ITSS sample based on a screening carried out within the framework of the business survey.

Data collection process

As stated above, the analysis of the first set of answers to the ITSS screening question in the business survey confirmed the already existing suspicion that incorrect reporting is and will be a major obstacle for producing a strong ITSS sample and strong ITSS data. Therefore, a major objective for the mission was to define measures to be taken with a view to improving the quality of the reports.

The most important measure decided upon relates to the interviewers/personnel statisticians working in Geostat's regional offices. These interviewers have phone contact to practically all reporters before the submission of each round of reports and therefore constitute and important channel for educating reporting units on how to report ITS. It was decided that interviewers will actively address the question on ITS for all units they talk to during the next round of data collection in the business survey. A suitable process for training the interviewers in talking to reporting units about ITS was also defined. Finally, it was agreed that Geostat will monitor the results from the upcoming rounds of data collection in the business survey and keep Statistics Denmark informed about the results in the period until the next mission in Georgia.















Analysis of existing administrative data sources, identification of potential new data sources

Geostat presented a complete overview of sources used in the current compilation of ITSS. As the final compilation of ITSS takes places in the National Bank of Georgia, the bank was able to supplement with important information about data manipulations which are carried out in the bank, such as CIF/FOB-corrections, estimates of purchases by foreign students etc. In general, it was concluded that the current compilation procedures are adequate, but it was underlined by the consultant that insofar as compilation steps remain in the National Bank of Georgia, documentation for these steps should be made available to Geostat. Moreover, FISIM was identified as one, where no data are currently compiled. Therefore, compilation of FISIM will be an issue for the remaining missions. Finally, potential new administrative data sources were discussed and a list of potentially useful sources was put together for further examination by Geostat before the next mission.

Designing the questionnaire for a new ITSS survey

Both the BPM6 classification of services and the EBOPS classification were discussed as potential frameworks for defining the questionnaire for Geostat's ITSS survey. Geostat considered it more feasible to start the new survey by using the BPM6 classification in combination with elements from EBOBS which are considered significant for the Georgian economy. The consultant approved of such a gradual implementation of EBOPS as being in line with the recommendation in IMTS2010. Based on this discussion, it was agreed that Geostat will prepare a final and full draft of the new questionnaire for mission 1.2.C.

Instructions for filling in the questionnaire

It was acknowledged that current instructions on the ITS questions in the survey on external economic activities are not sufficient. Therefore, a more thorough set of instructions must be produced for the new ITSS survey. The set of instructions used by Statistics Denmark to guide reporters of ITS was reviewed and it was agreed that Geostat will produce a proposal for a new set of Georgian instructions for the next mission.

Work plan

The mission finished by reviewing the work plan and making all relevant adjustments based on the decisions made during the mission.

3. Conclusions and recommendations

- The guidance of PSIs regarding their reporting of ITS should remain a main focus for Geostat during the next rounds of data collection in the business survey.
- Direct contact between Geostat's interviewers and all reporting units to the business survey will be the main instrument for ensuring better reports.
- The results from the next rounds of data collection in the business survey should be monitored and additional measures for guiding reporters should be introduced if deemed necessary.
- A number of potential new administrative sources will be examined further by Geostat.
- The future work division between Geostat and National Bank of Georgia must be clearly defined and for all compilation processes remaining in the National Bank of Georgia thorough documentation must be made available to Geostat.
- Geostat will aim at a gradual implementation of the full Ebobs classification.
- Instructions for filling in the ITSS questionnaire must be enhanced.
