

Danish Foreign Affiliates 2013

(Danske datterselskaber i udlandet 2013)

This survey is regarding foreign affiliates (foreign being here outside Denmark) and, if any, affiliates to the affiliates etc., in which there are ownership of more than 50% of the capital/votes in the affiliate or control of the affiliate in case ownership less than 50%.

The period of the survey is the financial year of 2013. If the financial year for the Danish company does not follow the calendar year (1 January 2013 - 31 December 2013), then it will be the financial year that <u>ends</u> in the period between 1 May 2013 and 30 April 2014. Please state the financial year on the front page of the form, under: *Angiv hvilken periode virksomheden indberetter for:*. Mark with an X in the box *Kalenderåret 2013* if the financial year is the calendar year or in the box *Anden regnskabsperiode. Angiv hvilken:* if the financial year does not follow the calendar year, and please state the period, DDMMYY.
