### **1. General comments**

This Study visit mission report was prepared within the EU Twinning Project "Strengthening the Capacity of Georgian Statistical System". The study visit was carried out within component 3 of the project "Development of Business Statistics" under sub-component 3.2 "Statistical Business Register (SBR)".

The purposes of the study visit were:

• To be introduced to the Danish model of the Business Register, Group of Enterprises, storage and usage of Frozen Frame and information exchange systems.

#### 2. Summary

Within the framework of "Twinning project", we participated in a study visit organized by Statistics Denmark. This visit covered the topic of Statistical Business Register.

From the Danish side, meetings were held by Steen Eiberg Jørgensen and Christian Bendtsen.

During the meeting experts from Statistics Denmark shared their experiences on important issues such as:

- Database update system;
- Discovering a group of enterprises, recording the necessary information about them, profiling and producing statistical indicators based on this information;
- Determining the periodicity and timing of storage of Frozen frame, using them for statistical purposes;
- Data Collection System;
- How to work together with statistical departments
  - Sharing information /workflow
    - User group;
- Sample Administration System etc.

During our mission we also discussed some of the methodological basis of the Business Register, remaining issues on the sub-component and, again, a future work plan for Geostat.

The Study visit to Denmark was overall interesting and fruitful. Obtained information and knowledge will help us further to better organize and update the Business Register database and produce more diversified statistical information based on the BR database.
