1. General comments

This mission report was prepared within the Twinning Project „Support to the State and Entity Statistical Institutions, phase V”. It was the second mission to be devoted to dissemination within Component 3.3 of the project. The topic of this mission was to train staff from BHAS, FIS and RSIS in various methods used for understanding and formulating the needs of statistical users in order to develop a dissemination strategy.

The concrete objectives of the mission were:

The views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, BHAS / FIS / RSIS or Statistics Denmark.

2. Assessment and results

Through the training course (annex 3) the staff of the three BiH statistical organisations was introduced to the European Code of Practice on dissemination and best practice. Activities and procedures to put in place in order to establish a dissemination following these principles were discussed.

It was stressed that dissemination is not directly regulated through legislation by the European Union but the Code of Practices used by Eurostat and its members has number of principles that defines the how statistics must be disseminated in order to be reliable, trustworthy and politically independent.

It was stated that *users* should be the focus of all dissemination. So knowledge of users, their competences, needs and environment is the key to all activities in dissemination.

Building trust with users is a task that is important and possible through informing about the quality of the data, through documentation and through procedures for correcting and informing about errors.

The establishing of an interactive database on the website to disseminate – among other thing- the Census data was suggested. The PX-Web database was demonstrated as suitable for this purpose and is already used by more than 50 statistical organisations including offices in the region: Slovenia, Croatia and FyRoM (Macadonia), Albania and Moldova. It is suggested that a database containing data from the country, BiH as a whole is established. This does not prevent the RSIS and FIS from disseminating ‘local’ data in similar databases. But it is – again from a user’s perspective very important to find data from the country in one place.

Also ideas and suggestions for the planned yearbook were discussed. Methods and templates for production of year book and other thematic publications will be demonstrated in the coming study visit to Statistics Denmark.

3. Conclusions and recommendations

It is recommended by the EU experts that PX-Web is to be used as the general dissemination database in all three organisations

- The coming study visit to Statistics Denmark was discussed and suggestions for content should include.
 - Publication production including the process producing the yearbook
 - Templates to help/secure standardized publications
 - Statistics Denmark's set-up for web and database
 - Relation to the media/the press
 - Relation to users
 - Organisation of dissemination and cooperation internally with subject matter divisions.
 - Marketing /profiling statistics and the statistical office
- PX-Web as a common output database solution for all statistics (license around 5500 Euro for all)

- Presentation of PX-Web to the management, as background for a decision on database, as it is part of the overall strategy.
