

# **1. General comments**

This final report was prepared within the EU Twinning Project" Support to the reform of the statistics system in Bosnia and Herzegovina".

Due to the outbreak of COVID-19 the last scheduled mission to take place 10 - 12 March 2020 was cancelled. For the same reason this report will be limited in scope and will only include few comments to the following chapters.

The consultants would like to express their thanks to all officials and individuals met during the missions carried out under this project for the kind support and valuable information which we have received during our stays in Bosnia-Herzegovina and which highly facilitated the work of the consultants.

This views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, BHAS, FIS, RSIS, CBBH, Statistics Denmark, INSEE, Statistics Finland and Croatian Bureau of Statistics.

# 2. Status at the beginning of the project

No construction producer price indices (CPPI) for civil engineering existed for BiH.

## **3.** Status of project results

The mandatory result for this sub-component was:

# Construction producer price index for division F42 – Civil engineering works produced by 8th project quarter.

This result has been achieved with the results of CPPI for Civil Engineering being produced and later published at 25 February 2020 for the years 2017-2019.

Methodology for CPPI for Civil Engineering has been finalised and will be published April 2020.

A quality report has been prepared and will be published in April 2020.

As written under the general comments, the last mission was cancelled due to the outbreak of COVID-19.

### 4. Sustainability of the achievements

### **5.** Recommendations for the future (short and long term)

Firstly, it is highly recommended that relevant resources, meaning staff, should be allocated to the CPPI for civil engineering as the data collection is quite demanding due to the need for personal contact to the reporting units. This could possibly be achieved by introducing web-based questionnaires individualized to each reporting unit with prescribed prices for the previous period and asking the reporting units to report prices for the current period. This could have the benefit of making it easier to obtain the relevant data from the reporting units.

Secondly, the CPPI for civil engineering relies on information from a bill of quantities. This bill of quantities should be updated within the next 5 years to ensure that the statistics is up to date.

Thirdly, experiences with data collection, data validation and index calculations should be exchanged on a regular basis, e.g. by setting up quarterly meetings. This will help ensure that the methodology behind the indices can be up to date and that the production of the indices undergoes ongoing adjustments to further improve the efficiency of the production.

## 6. Identification of needs for additional support

Updating of the bill of quantities is made by an independent expert. It is not known by the MS experts if future payments for this service are included in the budgets of the statistical institutions of BiH.
