1. General comments

This mission report was prepared within the EU Twinning Project "Strengthening the Capacity of Georgian Statistical System". This was the second mission within the sub-component 2.4: "Evaluation methods of non-observed economy" as activity 2.4.B "Further preparation of identification and methodological documentation". Due to the Covid-19 restriction the activity was not able to arrange as fysical meeting in 2020 and it was organised as 2-3 hours Remote Sessions (RS) in these dates: September 28th and 29th, October 26th and 30th, November 3rd and 6th.

The purpose of the mission was to present, discuss and work on the below mentioned subjects:

- Continued discussion on NOE categories in activities of NACE rev. 2 revealed during 2.4.A;
- Preparatory works for identifying and systemizing NOE according to Eurostat's Tabular Approach to Exhaustiveness;
- > Data collection for the Labour Input Method (LIM);
- Description of methodology for estimation of N.3, N.5 and N.7 in Georgia;
- \blacktriangleright Preparation of survey on N.6.

Expected output of the activity were:

- ▶ NOE categories in activities of NACE rev. 2 revealed during 2.4.A have been discussed;
- Preparatory works for identifying and systemizing NOE according to Eurostat's Tabular Approach to Exhaustiveness have been conducted;
- Data collection for the LIM;
- > Description of methodology for estimation of N.3, N.5 and N.7 in Georgia have been performed;
- Survey on N.6 prepared;
- Mission report written;
- > ToR for next activity prepared.

Due to the sensitivity of several NOE components (illegal activities, tax cheating etc.), it was not possible to discuss all the planned topics via video meeting.

The views and observations stated in this report are those of the consultant and do not necessarily correspond to the views of the European Union, GEOSTAT, Statistics Denmark, or other statistical institutions involved in the implementation of the project.

2. Assessment and results

There are two main data sources for the LIM: Labour Force Survey (LFS) as labour supply and Structural Business Statistics (SBS) as labour demand. The data were collected from relevant departments by 2-digit NACE rev.2:

LFS is in national concept:

- > Main job (full time, part time) and secondary job
 - Number of jobs
 - Total actually hours worked
 - Average actually hours worked
 - Employees
 - Self-employed with employees
 - Self-employed without employees (own account workers + Members of producers' cooperatives)
 - Unpaid family workers

















- Workers abroad
- > Calculation of Full Time Equivalent (FTE) jobs

















SBS is in domestic concept:

- Number of employed persons
- Number of hired persons
- Number of working hours
- Calculation of the FTE number of employed persons
- > Calculation of the FTE number of self-employed persons

Non-SBS (additional administrative data source):

- ➤ A: Agriculture, forestry and fishing
- ► K: Financial and insurance activities
- M: Professional, scientific and technical activities
- > O: Public administration and defence; compulsory social security
- ➢ P: Education
- > Q: Human health and social work activities
- ► R: Arts, entertainment and recreation
- ➢ S: Other activities
 - Number of employees

Additional adjustments:

- To deduct residents working abroad
- > To add non-residents working in Georgia (permits issued by the Ministry)
- ➤ To deduct maternity leave from LFS
- > Institutional households are not covered by LFS How many persons living in the institutional HH?
- Agriculture already includes the NOE (Agriculture is fully covered) Number of employed in agriculture?

Rules for distributions between S.11 and S.14 are not done yet (development of Sector accounts is needed).

Other NOE categories discussed:

- ≻ N.3
 - Individual housing construction (IHC) should be split into:
 - new construction (number of permits) the value of the house during the construction procedure and during the building approval
 - reconstruction the value of the house during its lifetime its value must be invested in the form of reconstructions
 - GEOSTAT would like to add also private tutors (they are not obliged to register)
- ≻ N.5
 - It is necessary to find out how is it with "free jobs" (they are not sometime in the Business Register are not subject to statistical surveys but they could registered by Tax Authorities).
- ≻ N.7
 - Tips: mainly to taxi drivers, waiters and hair dressers. There should be request on the Household Budget Survey (HBS) to add question on the tips in the HBS questionnaire.

3. Conclusions and follow up

















The compilation of the LIM for NOE estimation category N.1 in the NA department in the GEOSTAT was done. However, there are still several doubts in the results, which should be discussed and analysed:

- > To check the data sources (LFS and SBS) if they were handled correctly;
- To check the LIM compilation that the calculation of the FTE on supply and demand sides was made correctly;
- > To discuss negative results in several NACE.

Possible data sources and methodology for estimations of NOE categories N.3, N.5 and N.7 were also discussed.

- Preparation of methodological documentation regarding methods used for measuring non-observed economy in the country, according to the tabular approach of Eurostat;
- > Analysing progress of conducting special surveys regarding measuring non-observed economy;
- Meetings with illegal activities experts (drug trade, sex-business, smuggling) and Tax Authorities experts;
- Data collection for the illegal activities;
- ➤ Analysis of LIM;
- Estimation of N.2 (illegal activities);
- Description of methodology for estimation of N.3, N.5 and N.7 in Georgia;
- Estimation of N.3 and N.5;
- Preparation of survey on N.6;
- Description of methodology for estimation of N.1 and N.2;
- Proposed date: 2 STEs x 5 working days in April 2021.

Activity 2.4.SV: Study visit to get inspiration from MS experience

- Study visit to the Czech Republic to gain insight into the estimation of NOE and the method of evaluation of NOE in the Czech Republic
- Possibility to discuss subjects under sub-components 2.3 and 2.4 on the same study visit
- Proposed date: 5 persons x 3 working days + 1 RTAA/Interpreter (the date will be decided after COVID-19 situation)
