1. General comments

This mission report was prepared within the EU Twinning Project "Strengthening the Capacity of Georgian Statistical System". It describes the fifth mission within *Component 1.2: Statistics on International Trade in Services (ITS) compiled*. Before this mission, work within the subcomponent had mainly focused on defining a sampling frame for a new ITSS survey and creating sampling and grossing up procedures. Moreover, a pilot survey had been carried out. Following the pilot survey, the specific purposes of this mission were to discuss and work and the below mentioned subjects:

- Nil reports to the pilot survey
- Evaluation of fully compiled pilot statistics
- Finalize validation and validation procedures
- Revisions to questionnaire
- Discussion of data dissemination
- Routine work description

The consultants would like to express their gratitude to all officials and individuals met for the kind support and valuable information which they received during the stay in Georgia and which highly facilitated the work of the consultants.

2. Assessment and results

During the mission it was possible to take further steps towards the final objective of the subcomponent. However, not all the foreseen tasks could be solved. Therefore, a significant amount of work remains to be done before and during the last mission within the subcomponent, which will take place in October 2021.

The largest and most important task within the mission was to compile a full pilot statistics based on the pilot survey and relevant supplementary sources. National Bank of Georgia had carried out significant preparatory work in this area and presented plans for the compilation process. A core focus point was transportation services where several issues must be solved. Firstly, there are cases were reporters claim that they cannot deliver a country distribution for passenger transportation. Secondly, it must be decided how survey data on freight transport should be combined with traditional CIF-FOB-corrections. While National Bank of Georgia presented significant input to the solving of these (and other) issues, work still remains to be done. Moreover, solutions proposed must be described in greater detail on order for the experts to deliver substantial feedback. This also implies that changes proposed by Geostat to the questionnaire can only be evaluated by the experts when the compilations plans are final and well understood.

Besides the work related to the compilation process, data validation was a major theme for the mission. Geostat informed that a new project will be undertaken together with International Trade Center ITC). ITC has proposed to assist in defining data validation for the new ITSS survey within this new project. This approach seems reasonable as longer time series will be available during the ITC project, which will make it easier to define good validation procedures. It was agreed, however, that DST will presents its own validation in more detail during the next mission as an input for the further process. Moreover, Geostat will carry out a preliminary validation of the pilot survey. Afterwards, final validation procedures will be defined within the ITC project.

Dissemination plans were also discussed during the mission. As part of the targets for the twinning component, the final pilot statistics will be shared with EUDB and NBG in November 2021. Moreover, pilot statistics will be published as experimental statistics on Geostat's webpage starting from Q1 2022, accompanied by a press

















release. For this purpose an official note stating what "experimental statistics" implies as compared to "standard statistics" must be written. This will be part of the next mission.

Finally, the so-called routine work descriptions were discussed. Routine work descriptions are standard metadata documents describing methodology behind Geostat's statistics. Several different formats exist, so it must be decided which one to apply. Geostat will clarify internal expectations regarding this matter before the next mission. Drafting of the routine work descriptions will take place during the next mission.

3. Conclusions and recommendations

Progress has been made during the mission. However, as stated above the step from a pilot survey to a fully compiled statistics has proven to be difficult and some work in this area still remains. As the next mission (in October 2021) will be the last one within this subcomponent, it will be important to ensure that the work related to compilation of the statistics can be finalised during that mission. Therefore, the experts have recommended that the preparatory compilation work should be split into several deliveries to be accomplished in the period before the next mission. This will make it easier to monitor the progress and ensure that a full pilot statistics can be reviewed during the mission. Based on this recommendation, Geostat and NBG have composed a compilation calendar, which is copied below. It is the view of the experts that deliveries according to the compilation calendar will make it possible to finalise the work within the subcomponent and achieve the results foreseen in the twinning project.
