During the first 3 months of the project, four assessment missions have been completed according to the plan. MS experts have discussed with BC experts on issues related to national accounts, productions statistics, structural business statistics, salaries and wage statistics.



The project has in the first 3 months welcomed leading experts from Denmark, Lithuania and Finland. The first period has been hectic, but in an atmosphere full of enthusiasm, fruitful cooperation and highly skilled professionals from different countries meeting in Kyiv.

During the coming 3 months, 13 missions are planned.

I would like to end this newsletter by highlighting the first upcoming study visit of experts from SSSU and L'viv Regional Statistics Office on dissemination database. The study visit will take place from 29 February through 2 March 2012 in Copenhagen, Denmark.

The four completed missions overview:

Industrial production: How PRODCOM statistics are produced in Lithuania and Denmark, i.e. survey characteristics, contract processing, treatment, maintenance and issues concerning PRODCOM survey.

Salaries and wages: Ukrainian labour market statistics, current EU legislations on earnings and labour cost statistics.

National accounts: How the national accounts can compile the production accounts and income generation by NACE Rev.2.

Structural business statistics: Assessment of current structural business statistics and the need for changes in order to implement NACE Rev.2.
