

Map of the changes in service codes

Processing and related transactions

- New information collected in the ITS questionnaire:
 1. Manufacturing services on physical inputs owned by others (200.4)
 2. Purchases of goods abroad to be processed abroad (304)
 3. Sales of goods abroad after processing abroad (305)
- Challenge: Goods sent for/received after processing must be identified in the ITGS in order to be excluded from the BoP goods account

Processing - identifying the goods flows

- Nature of transactions codes (NoT) and Customs procedure codes (CPC) from the ITGS used to identify the goods movements
 - NoT: only partly available in Denmark. Poor quality – new validation procedures implemented.
 - CPC: problematic source: 1) in terms of CPC inward processing flows might not be processing under contract. 2) expected under coverage in case of export for outward processing.
- Using NoT and CPC allows for adjustment at the detailed commodity level which provide coherence with the SU tables.



Processing - validation

- ITGS vs. ITSS
 - A validation system shared between the two statistical domains has been established
 - In addition to checking for internal inconsistencies of the NoT reports we check for consistency between reported information on the ITG and ITS questionnaires.
 - Using CPCs to check for consistency with ITS reporting; validate the processing fee
- “Industry sales” valuable for error checking purposes
