ToR Terms of Reference

1. General comments

This was another great experience of open discussions and commitment from ICBS partners and the MS Expert would like to express his thanks to all officials and individuals met for the kind support and inspiring discussions during the stay in Israel which highly facilitated the work.

The views and observations stated in this report are those of the MS Expert's, and do not necessarily correspond to the views of the European Union or Statistics Denmark.

2. Activities during the mission

The program laid out in the ToR was followed with full engagement from the top management. This included:

- Discussion about the plans for the rest of the component in the project
- A half-day workshop on the exact scope and contents of the recommendations on metadata system in component E4.1.
- The successful conduct of the Steering Committee, which was extra encouraging because of the strong support from the EU Delegation.
- A half-day workshop with the top management on how to strengthen the work with the long term strategy.
- Meetings with two partner producers of official statistics in Israel, the National Insurance Institute and the Ministry of Finance. The outcome of these meetings was agreement to work towards a better coordination and mutual assistance in fulfilling user needs. Work will continue towards a MoU with each of these partners.

3. Recommendations for activities in the coming months

The following recommendations were presented and accepted by the ICBS management:

3.1 Recommendations on NSS

ICBS started work with partners, trying to agree on MoU with each major partner. The beginning with the National Institute of Insurance and the Ministry of Finance during the mission was very promising. By the end of the project, there should be MoUs agreed with at least 3 important partners. Progress will be reviewed in September.

There seems to be a promising start for an efficient Public Council for Statistics. However, it has not yet convened for the first time. A subcommittee has been formed, and it seems it will try to propose a "Statistics Hub", which should unite first macro data, subsequently even micro data, together with metadata, from many agencies. This is very promising and is encouraged.

ICBS should also work on a long term objective of being able, to a larger extent, to utilize micro data from partners. This should be one of the objectives in the Strategy.

3.2 Recommendations on Long term strategy

It was agreed to put more power to the strategy group, as progress has been slow; Yoel Finkel will now be the chair and responsible for driving the process.

There should be a Management Seminar outside the office regarding the long term strategy in June.

Before this event, the ICBS will prepare a draft that can fuel the discussions and make them concrete, leading to a full strategy, which must be agreed before the end of the project. Progress will be reviewed in September.

3.3 Recommendations on Organisation

The management will take steps to make the organisation clearer and make sure that all stakeholders in important positions in the organisation contribute constructively to the common strategy.

3.4 Recommendations on metadata

Management commitment for a common metadata system has been confirmed. The metadata strategy will be based on international content and technical standards, while taking national needs into account. This way the management will be guiding staff to help users and be effective.

The management will:

- Give direction to the work
- Invest resources, manpower as well as necessary IT infrastructure
- Adopt standards
- Make metadata part of the Strategy

It should be investigated if it is possible to have one more activity on metadata in the project.

3.5 Other issues

A strong interest in the Research Services of countries like Denmark, the Netherlands and Sweden was recognised. Similar arrangements, giving researchers better opportunities to use detailed and tailor-made micro data to do important research, could be developed in Israel. It could be a subject of a coming Twinning Project. Statistics Denmark will as an inspiration send some material about the Danish service, which currently serves 1,400 researchers outside Statistics denmark.
