

Executive Summary

1. Background and brief history

The objective of the first mission was to get familiarized with the existing data collection systemof foreign direct investment (FDI)of the Ukraine. The main areasof observation during the mission included, effective methodological principles, data sources and the dissemination of data related to direct investment. Moreover, recommendations for implementing certain provisions of direct investment will be prepared by the EU expert in compliance with the OECD Benchmark Definition of Foreign Direct Investment 4th edition.

2. Obstacles

There were two main limitations hat made it difficult to get an understanding of what was actually required. The first hurtle was the combination of two missions into one. More specifically, the combination made it difficult to get a clear understanding of the areas of improvement with such a short amount of time spent on the component, FDI.

Secondly, the late arrival of documents translated into English. This late arrival made it difficult to understand the sources of data collection and a more thorough session of questions and answers was never possible.

3. Next steps

However, with the mentioned obstacles already in place, the mission was able to further workin achieving threeconsiderations of improvement. The considerations are as following:

- a. Suggestions on the survey 10-fea foreign direct investment in the Ukraine
- b. Mirror statistics
- c. Suggestions in handling respondents that no longer can be found

1. General comments

This mission report was prepared within the Twinning Project Development of new statistical methodologies and indicators in selected areas of statistics in line with EU statistical standards". It was the first mission to be devoted to foreign direct investment within Component 3.2 of the project. The mission was aimed at defining a strategic plan forming the base of the further implementation of the project in this statistical area.

The concrete objective of the mission was:

- To give consultation for improving the methodology of the surveys
 - presentation of the objectives of the mission
 - where necessary reference to other parts of the project / to other missions
 - where necessary background information

2. Assessment and results

In the Ukraine FDI data is collected through surveys sent to respondents that fall within the criterion of 10% or greater ownership. These surveys are done on a quarterly basis. A business register is used to extract a survey population. Regional statistical offices collect and compile the micro FDI figures and send the figures to the main statistics headquarters (State Statistics Service of Ukraine) in Kyiv. The SSSU is in close cooperation with the National Bank of Ukraine who is in charge of compiling the balance of payments and also any methodologies used.

The objective of the first mission was to get familiarized with the existing data collection system of foreign direct investment (FDI) of the Ukraine. The mission was able to further work in achieving three considerations of improvement. The considerations are as following:

In conclusion, a couple suggestions on survey 10-fea could be code 10 Acquisition of corporate rights due to privatisation of state property. This code 10 is difficult to deduce if it is incorrect in the translation, but rights or licenses, etc. are not part of foreign direct investment but are rather part of capital transfers. A second suggestion might be the addition of greenfield investments. It is difficult to find in the survey if a specific investment is a greenfield. Greenfield, in other words is a new establishment whether it may be Ukrainian aboard or foreign establishment in the Ukraine.

As mentioned during the mission, mirror statistics are a difficult area for foreign direct investment. Difficulties are present due to the fact that different methods of compiling these statistics are common between countries. The European Union is trying exercises in order to decrease the asymmetries in FDI statistics.

Finally, suggestions related to the handling of respondents that no longer can be found. This is also an area a bit outside of the scope of foreign direct investment and involves the basic infrastructure of a business register. For example if an enterprise is dormant in Sweden it is still required by law to report to the business register.
